
**Re: Comcast of Contra Costa, Inc. – Notice of Operation Under State-Issued Video Franchise in Pinole, California**

Dear Ms. Espinosa:

By this letter, we hereby notify the City of Pinole that Comcast of Contra Costa, Inc. ("Comcast") is now providing continued video service in Pinole pursuant to a state-issued video franchise, in lieu of the former local franchise, consistent with California's recent state video franchise law. In its capacity as the state franchising authority under the Digital Infrastructure and Video Competition Act of 2006 (*See* Cal. Pub. Util. Code § 5800, *et seq.*), the California Public Utilities Commission issued a California video franchise certificate that gives Comcast the right to offer video service in Pinole pursuant to state authority. The certificate is effective April 19, 2009. Comcast will begin operating under its state franchise as of that date. A copy of the franchise certificate is enclosed for your records.



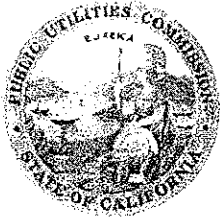
