GridSME had an opportunity to provide an Independent Evaluation (IE) for five entities of their 2020 WMP's. Below are a list of questions / comments from GridSME serving as an IE regarding the WSAB's DRAFT Guidance Advisory Opinion:

- 1. It is recommended that the WSAB provide feedback and comments to each of the POU's 2020 WMPs. Individual POU feedback, for these first 2020 filings, will not only benefit the POU but also the IE and would help in improving the future plans and reports. The WSAB could then consider, in future years, providing general comments to the overall POU community.
- 2. The WSAB should consider developing a "guidance document" for WMP Independent Evaluators. A guidance document will ensure that there is more consistency in the format and the detail expected from the IE in the final WMP reports.
 - a. Or create a template and require each IE to use the template as the guide for writing the IE report.
- 3. As an IE GridSME has the technical expertise to evaluate and comment on any type of black swan event that a POU my analyze. However GridSME is of the opinion that a black swan event, other than a catastrophic wildfire, is out of scope of what is required in a WMP per Public Utilities Code §8387.
