The Commission adopted Resolution M-4839 on January 10, 2019, which changes the Public Utilities Commission Reimbursement Account user fees pursuant to Public Utilities Code Sections 421 and 432. The new fee for water utilities is 0.0123 (1.23%) x Revenue.

This advice letter (AL 69) is submitted pursuant to General Order 96-B, Water Industry Rules. AL 69 is designated as a Tier 1 advice letter and the attached tariff sheets will become effective on April 1, 2019 upon approval by the Commission.

Due to the nature of this advice letter, no protest or response period is necessary, further no documentation has been sent to the Tahoe Park Water Co. service list.

SURCHARGE TO FUND PUBLIC UTILITIES
COMMISSION REIMBURSEMENT FEE

APPLICABILITY

This surcharge applies to all water and sewer bills rendered under all tariff rate schedules authorized by the Commission, with exception of resale rate schedules where the customer is a public utility.

TERRITORY

The unincorporated areas including Tahoe Park, Miramar Heights, Tahoe Sierra Estates Subdivision, Skyland and Nielsen Subdivisions, and vicinity, located adjacent to State Highway 89 approximately 2 to 3 miles south of the community of Tahoe City, Placer County. (T)

RATES

A 1.23% surcharge shall be added to all customer bills. (C)

SPECIAL CONDITIONS

In 1982 the legislature established the Public Utilities Commission Reimbursement Fee to be paid by utilities to fund their regulation by the Commission, Public Utilities (PU) Code Section 401-443. The surcharge to recover the cost of that fee is ordered by the Commission under authority granted by PU Code Section 433. (T)
