Background and Compliance with Executive Director Peterson Instructions

On March 17, 2021, Executive Director Peterson issued a letter to all Class C,D Water and Sewer utilities in which she directed utilities to extend customer protections to customers affected by COVID-19 pandemic through June 30, 2021, and also extend the appropriate Memorandum Account to June 30, 2021.

CMWC filed Advice Letter 47-W on November 16, 2020 requesting approval from the Commission for the sale and revocation of its Certification of Public Convenience and Necessity (PPCN) and utility tariffs due to the sale of CMWC to the Cobb Area County Water District (CACWD). Water Branch has not prepared the necessary Resolution for the Commission to act on this Advice Letter and has not informed the CMWC that it objects to the Advice Letter. Water Branch has had Advice Letter 47-W now for 127 days and the utility expects the Commission approval soon. CACWD does not now charge late fees or discontinue service in accordance with the Governors Order. The transfer of ownership will not affect the protection of customers due to COVID-19 pandemic, just how its done.

The utility discontinued posting to its Memorandum Account because it will never be able to collect from this Memorandum Account after the transfer.

No Effect on Water Service

This Advice Letter filing will not cause the withdrawal of service, nor conflict with other scheduler or rules.

- (5) The relief requested in the advice letter requires consideration in a formal hearing; or
- (6) The relief requested in the advice Letter is unjust, unreasonable, or discriminatory. (provided that such a Protest may not be made where it would require re-litigating a prior order of the Commission).

Any Protest or Response must be made in writing or by electronic mail and must be received by the Water Division of the Commission within 20 days of the date this Advice Letter is filed.
