F. MEMORANDUM ACCOUNT FOR LEGAL AND CONSULTING SERVICES COSTS

- 1. PURPOSE: The purpose of this memorandum account is to record legal and consulting services costs associated with predatory or vexatious individuals, groups, or private entities that may attempt to interfere with operations and maintenance, harass and intimidate company employees, contest property rights or lawsuit settlement agreement conformance, or take assets of Tahoe Park Water Company (Tahoe Park) that would not be in the best interests of the ratepayers. The balance in the memorandum account will be recovered in rates after CPUC review and audit of the recorded entries. The authority to establish this account is Standard Practice U-27-W.
- 2. ACCOUNTING PROCEDURE: Tahoe Park will maintain a memorandum account for its unanticipated expenses and any recovery/reimbursements. These expenses will be additional or incremental to those allowed in Tahoe Park's last general rate case proceeding. Tahoe Park shall make entries to this account at the end of each month as follows:
 - a. Debit entries equal to the incremental or additional amounts recorded in Tahoe Park's operations and maintenance and administrative and general expense accounts that were incurred as a result of the legal and consulting services costs.
 - b. Debit or credit entries to transfer all or a portion of the balance in this memorandum account to other adjustment clauses for future rate recovery, as may be approved by the Commission.

Tahoe Park shall file an advice letter with the Commission detailing any surcharge or capitalization recovery of these costs.
