CALIFORNIA WATER SERVICE COMPANY (U 60 W)

To The Public Utilities Commission of the State of California:

California Water Service Company ("Cal Water") hereby respectfully submits this Tier 1 advice letter requesting authority to make changes to the tariff schedules listed in **Attachment 1** for the Dominguez, East Los Angeles, Hermosa-Redondo, Antelope Valley (Los Angeles County Region), Palos Verdes (Los Angeles County Region), and Westlake tariff areas. *Please note that this advice letter will only be distributed electronically to the Water Division and the attached service lists.*

Summary

In Advice Letter 2465, Cal Water proposed revenue increases to reflect the higher costs associated with purchased water and pump taxes in ratemaking areas detailed below. The tariff schedules inadvertently used the incorrect rate design and generated inaccurate rates for the Los Angeles County Region tariffs only. This supplement to AL 2465 corrects the rates reflected on the tariff schedules for the Los Angeles County Region.

Discussion

The basis for the revenue increases in the table above is described for each ratemaking area below.

Dominguez:

Purchased water for the Dominguez District is obtained from the West Basin Municipal Water District (West Basin). Effective January 1, 2023, West Basin will increase its potable water rates by \$87 per acre-foot.

East Los Angeles:

Purchased water for the East Los Angeles District is obtained from the Central Basin Municipal Water District (Central Basin). Effective January 1, 2023, Central Basin will increase its quantity



rates for Tier 1 from \$1,313 to \$1,379 per acre-foot. In addition, the Water Replenishment District of Southern California increased its pump tax rate from \$394 per acre-foot to \$411 per acre-foot, effective July 1, 2022.

<u>Hermosa-Redondo:</u>

Purchased water for the Hermosa-Redondo District is obtained from West Basin. Effective January 1, 2023, West Basin will increase its quantity rates from \$1,488 per acre-foot to \$1,587 per acrefoot, and its recycled water rates from \$1,294 per acre-foot to \$1,520 per acre-foot. In addition, the Water Replenishment District of Southern California increased its pump tax rate from \$394 per acre-foot to \$411 per acre-foot effective, July 1, 2022.

Los Angeles County Region:

Purchased water for the Palos Verdes area (a sub-region of the Los Angeles County Region), is obtained from West Basin. Starting January 1, 2023, West Basin will increase its potable water rates from \$1,488 per acre-foot to \$1,587 per acre-foot.

Note that, in D.20-12-007, the Commission authorized a tariff split so that Antelope Valley customers would not have to fund the Palos Verdes Peninsula Water Reliability Project (PVPWRP) filed in Advice Letter 2387. Accordingly, Antelope Valley and Palos Verdes customers have returned to having different rates.

Westlake:

Purchased water for the Westlake District is obtained from the Calleguas Municipal Water District (Calleguas) and the Triunfo Water & Sanitation District (Triunfo). Effective January 1, 2023, Calleguas will increase its potable water quantity rates for Tier 1 from \$1,561 to \$1,632 per acrefoot. Because Triunfo recycled water rates are equal to 80% of the Calleguas potable water rates, water purchased from Triunfo will be \$1,306 per acre-foot.

Allocation of Revenue Increase:

Current rates are calculated based on a Commission-approved allocation of revenue collected from consumption-based rates versus fixed monthly service charges. Because the costs of purchased water and groundwater replenishment include variable and fixed charges in nature, in the Settlement Agreement adopted in D.20-12-007, Cal Water and Cal Advocates agreed that all revenue increases between rate cases should be reflected in both the quantity rates and service charges of Cal Water customers so that the authorized revenue allocation percentages are maintained. The rates proposed in this advice letter maintain the appropriate allocations.

<u>Typical Residential Bill Impact:</u>

The table below shows the monthly bill impact of these increases for the typical residential customer (based on median 2020 usage). The typical bill increases are based on incremental changes in rates calculated for purchased water and pump tax offset revenue increases only. The typical bill impact for Palos Verdes (Los Angeles County Region) was previously incorrect in AL 2465. The table below has been updated to reflect the correct lower impact.

Revisions to Tariffs:

AL 2645 sought to remove a paragraph from the Special Conditions section of Hermosa-Redondo District's Recycled Metered Service tariff pertaining to recycled water contracts because the provision is no longer applicable. AL 2645 also removed the Preliminary Statement M table for the five ratemaking areas addressed in AL 2645 because the WRAM/MCBA mechanism will no longer be in effect on January 1, 2023.

This supplemental filing seeks to correct the tariff schedules for the Los Angeles County Region identified in **Attachment 1** that were previously filed in AL 2465.

Requested Effective Date

Under General Order 96-B, Water Industry Rule 7.3.1, as modified by Resolution W-4664, this is a Tier 1 advice letter. Cal Water requests that the rates proposed in this advice letter become effective on **January 1, 2023**.

A protest objects to the advice letter in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

(1) The utility did not properly serve or give notice of the advice letter;

- (2) The relief requested in the advice letter would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
- (3) The analysis, calculations, or data in the advice letter contain material error or omissions;
- (4) The relief requested in the advice letter is pending before the Commission in a formal proceeding; or
- (5) The relief requested in the advice letter requires consideration in a formal hearing, or is otherwise inappropriate for the advice letter process; or
- (6) The relief requested in the advice letter is unjust, unreasonable, or discriminatory (provided that such a protest may not be made where it would require re-litigating a prior order of the Commission.)

A protest shall provide citations or proofs where available to allow staff to properly consider the protest. A response or protest must be made in writing and must be received by the Water Division within 20 days of the date this advice letter is filed. Cities and counties that need Board of Supervisors or Board of Commissioners approval to protest should inform the Water Division, within the 20-day protest period, so that a late filed protest can be entertained. The informing document should include an estimate of the date the proposed protest might be voted on.

The advice letter process does not provide for any responses, protests, or comments, except for the utility's reply, after the 20-day comment period.

Replies:

The utility shall reply to each protest and may reply to any response. Each reply must be received by the Water Division within 5 business days after the end of the protest period and shall be served on the same day to the person who filed the protest or response. If you have not received

This caused quantity rates to go up by the following amounts: \$0.0563/CCF for Tier 1 usage, \$0.0704/CCF for Tier 2 usage, (C) and \$0.1057/CCF for Tier 3 usage. Amounts collected from these quantity rate (C) increases will be tracked in a balancing account, as required by Section 792.5 of the Public Utilities Code, and will be trued up at a later time. Monthly service charges also went up, with the charge for a 5/8 x \%-inch meter increasing by \\$0.40. (C)

- 3. All bills are subject to the following tariff schedules: **Schedule UF** (CPUC reimbursement fee) and applicable surcharges and surcredits on Schedule RSF (Rate Support Fund), Schedule CAP (Customer Assistance Program), and Schedule AS (Additional Surcharges and Surcredits).
- 4. Any designated recycled water customer who refuses recycled service shall be subject to an additional charge equivalent to 50% of the current Calleguas Municipal Water District (CMWD) potable water rate. This charge was instituted by Ordinance No. 17 of the CMWD on July 15, 1994, which calculates to \$1.5391/CCF.
- 5. Water Expense Increase: Beginning on January 1, 2023, rates in this area will reflect a (C) 3.4% revenue increase (as compared to the revenue approved in Advice Letter 2437) (C) due to higher charges imposed by the Calleguas Municipal Water District. This caused quantity rates to go up by \$0.1500/CCF. Amounts collected from these quantity rate (C) increases will be tracked in a balancing account, as required by Section 792.5 of the Public Utilities Code, and will be trued up at a later time. Monthly service charges also went up, with the charge for a 5/8 x \%-inch meter increasing by \\$0.96. (C)

With the increase, a typical monthly bill for a Dominguez residential customer with a 5/8" x 3/4" meter who uses 9 CCF of water (which is 900 cubic feet, or approximately 6,732 gallons) per month will increase by \$0.91, or 1.7%.
