With this advice letter, SJWC requests authorization to implement a rate increase of \$24,331,436 or 5.9% to offset the increases to purchased potable water charges, the ground water extraction fee, and purchased recycled water charges that will be implemented by SJWC's water wholesalers effective July 1, 2022.

These tariffs are submitted pursuant to General Orders (GO) No. 96-B Water Industry Rules 7.3.1(7) and 8.4. This advice letter is designated as a Tier I Advice Letter. SJWC requests that the surcharges become effective on July 1, 2022.

Background

On June 9, 2021, SJWC filed Advice Letter 561A (AL 561A) to include in rates the increase in purchased water, pump tax, and recycled water costs from its wholesaler.

At its May 10, 2022 meeting, the Valley Water's Board of Directors formally adopted water rate increases for the 2022-2023 fiscal year, raising the groundwater rate (pump tax) to \$1,724 per Acre Foot (AF) and purchased water rate to \$1,839/AF effective July 1, 2022. The groundwater rate will increase by \$225/AF from the July 1, 2021 rate of \$1,499/AF (AL 561A) and the purchased water rate will increase by \$225/AF from the 2021 rate of \$1,614/AF (AL 561A).

Valley Water's groundwater charge for agricultural water will increase to \$36.85/AF which affects the agricultural discount provided by Valley Water and passed through in SJWC's tariffs. The current discount is 3.3628/ccf will increase to 3.8732/ccf (1.724/AF - 3.685/AF = 1.687.15/AF = 3.8732/ccf).

The updates to purchased water rate, groundwater rate, and agrigultural discount are reflected as Special Conditions in SJWC's tariff for Schedule No. 1 General Metered Service, Schedule No.1C General Metered Service Mountain District, and Schedule No. RW Raw Water Meter Service.

Changes to the rate for untreated water also affect the rate for purchased recycled water. South Bay Water Recycling, SJWC's wholesale recycled water provider, indexes recycled water wholesale rates to the rates charged by Valley Water for untreated water, with appropriate discounts for irrigation, industrial, or agricultural use. The recycled water discount remains at \$105 for irrigation, industrial, and agricultural uses. Effective July 1, 2022, wholesale recycled water rates will be increased by \$225 per AF from adopted July , 2021 rate of \$1,394 to \$1,619 per AF.

This updated to recycled water rate is reflected as Special Conditions in SJWC's tariff for Schedule No. RCW for Reycled Meter Water Rate.

Please see **Attachment A** for actual rate effective July 1, 2022. The following is a summary of total increase in costs:

Copies of detailed workpapers supporing the proposed rate increase and rate calculation have been provided to the Commission Staff in accordance with Standard Practice U-27-W.

Public notice of the offset rate adjustment will be completed by placing a notice (Attachment B) in the San Jose Mercury News as soon as possible. Proof of publication will be submitted to the Commission when the notification has been completed. In compliance with Paragraph 4.3 of

General Order 96-B, a copy of this advice letter has been emailed to all interested and affected parties as detailed in **SJWC's Service List**.

Effective Date

SJWC requests that the updated tariff sheets become effective July 1, 2022.

Protests and Responses

Anyone may respond to or protest this advice letter. A response does not oppose the filing but presents information that may prove useful to the Commission in evaluating the advice letter. A protest objects to the advice letter in whole or in part and must set forth the specific grounds on which it is based. These grounds may include the following:

- (1) The utility did not properly serve or give notice of the advice letter;
- (2) The relief requested in the advice letter would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
- (3) The analysis, calculations, or data in the advice letter contain material error or omissions;
- (4) The relief requested in the advice letter is pending before the Commission in a formal proceeding;
- (5) The relief requested in the advice letter requires consideration in a formal hearing, or is otherwise inappropriate for the advice letter process; or
- (6) The relief requested in the advice letter is unjust, unreasonable, or discriminatory (provided that such a protest may not be made where it would require relitigating a prior order of the Commission).

A response or protest must be made in writing or by electronic mail and must be received by the Water Division within 20 days of the date this advice letter is filed. The address for mailing or delivering a protest is:

The customer shall indemnify the utility and save it harmless from any and all claims arising out of service under this schedule and shall further agree to make no claims against the utility for any loss, damage or injury resulting from service under this schedule.
- 4. As a condition for service under this schedule, all customers are required to comply with all San Jose Water Company's tariffs, except for those identified in the Commission's General Order 103 regarding supply of water not intended or claimed to be potable.
- 5. Customers who receive water deliveries for agricultural purposes under this schedule, and who present evidence to the utility that such deliveries qualify for the lower pump tax rates levied by the Santa Clara Valley Water District for agricultural water, shall receive a refund of \$3.8732 per 100 cubic feet for the quantities of water used on the effective date of this advice letter. In accordance with Santa Clara Valley Water District procedures customers will be refunded every six months.

That pursuant to Section 26.5 of the Santa Clara Valley Water District Act ("District Act"), a written report detailing Valley Water's activities in the protection and augmentation of the water supplies of Valley Water has been prepared including: a financial analysis of Valley Water's water utility system, information as to the present and future water requirements of Valley Water, the water supply available to Valley Water, and future capital improvements and maintenance and operating requirements; a method of financing such requirements; a recommendation as to whether or not the groundwater production charge should continue to be levied in any zone or zones of Valley Water during the ensuing fiscal year; and a proposal of a rate per acre-foot for agricultural water and a rate per acre-foot for all water other than agricultural water for Zones W-2, W-5, W-7, and W-8;
- 2. That on the 25th day of February 2022, said report was duly delivered to the Clerk of the Valley Water Board;
- 3. That the Clerk, pursuant to Section 26.6 of the District Act, gave due notice of the receipt of the report and of a public hearing to be held commencing on the 12th day of April 2022, by teleconference, videoconference, or both and at the time stated;
- 4. That on February 25, 2022, written notice was mailed to all owners and operators of water-producing facilities within Valley Water's boundaries, advising of the proposed groundwater production charge rates to be levied, and of the opportunities to be heard concerning such charges;
- 5. That the Governor's Emergency Declaration related to COVID-19, and the Governor's Executive Order N-29-20 issued on March 17, 2020, allows attendance by members of the Board of Directors, Valley Water staff, and the public to participate and conduct public meetings and hearings by teleconference, videoconference, or both;
- 6. That pursuant to Section 26.6 of the District Act and consistent with the Governor's Executive Order N-29-20, on the 12th day of April 2022, at 6 p.m. via a virtual public hearing held by teleconference and videoconference, an opportunity was given to the public to comment on said report to Board members located at the Valley Water Boardroom and on video conference, was continued for further hearing to the evening of April 14, 2022 (teleconference and videoconference) and again to the evening of April 26, 2022 (teleconference, videoconference and in-person attendance in the Valley Water Boardroom located at 5700 Almaden Expressway, San Jose), and said public hearing was duly commenced and concluded, more than 45 days after notice of the hearing was given;

That during said public hearing, additional information and evidence was provided that was considered by the Board in making its decision on groundwater production charges, and the public and all persons subject to groundwater production charges were invited to speak or present written comments at the public hearing;
- 8. That the charges established by this resolution are for the purpose of paying the cost of constructing, maintaining, and operating facilities to import water into Valley Water; paying the cost of purchasing imported water; paying the cost of constructing, maintaining, and operating facilities for groundwater recharge, surface distribution, and the purification and treatment of water; and paying the principal and interest of any bonded indebtedness or other financial obligations of Valley Water incurred for those purposes;
- 9. That this Board considered all comments objecting to the proposed groundwater production charge increases for Zones W-2, W-5, W-7, and W-8;
- 10. That this Board, based on the whole record before it, finds that the revenues derived from the groundwater production charges will not exceed the funds required to provide services to Zones W-2, W-5, W-7, and W-8, as authorized under the District Act, and that the amount levied does not and will not exceed the proportional cost of service; and
- 11. That the California Environmental Quality Act does not apply to approval of these charges pursuant to the statutory exemption set forth in California Code of Regulations Title 14, Chapter 3, Section 15273, because, as identified in Valley Water's annual report on the protection and augmentation of the water supplies of Valley Water, the charges are expressly made for the purpose of:
 - a. Meeting operating expenses, including employee wage rates and fringe benefits;
 - b. Purchasing or leasing supplies, equipment, or materials;
 - c. Meeting financial reserve needs; and
 - d. Obtaining funds for capital projects necessary to maintain service within existing service areas.

Dear Courtney:

This letter is to inform you of the new recycled water wholesale rates that will be in effect during the 2022-2023 fiscal year. As you know, since July 2004 recycled water wholesale rates have been indexed to the rates charged by the Santa Clara Valley Water District (SCVWD) for untreated water, with appropriate discounts for irrigation, industrial, or agricultural use.

We have been notified by the SCVWD that the rate for untreated water will increase from \$1,499/AF to \$1,724/AF during the coming fiscal year (22-23). The recycled water discount per San José City Council Resolution 77326 is now \$105 for irrigation, industrial and agricultural uses. Therefore, the wholesale rates will be increased as shown in the table below. As a result, the following wholesale rates for recycled water will be in effect for the period July 1, 2022 through June 30, 2023:

NOTICE OF ADVICE LETTER FILING SAN JOSE WATER COMPANY'S FILING TO INCREASE WATER RATES ADVICE LETTER 577

Effective July 1, 2022, Valley Water, the wholesale water supply agency to San Jose Water Company (SJWC), will increase rates for purchased water and groundwater extraction fees charged to SJWC. If the CPUC approves this advice letter, effective July 1, 2022, rates will be recalculated to reflect actual water consumption in 2022. This will impact your bill.

Why is SJWC requesting this increase?

SJWC pays fees to pump groundwater and to purchase treated water from Valley Water, Santa Clara County's wholesale water supply agency. On May 10, 2022, Valley Water voted to increase wholesale water charges by 15% effective July 1, 2022 through June 30, 2023. SJWC purchases over 90% of its water supply from Valley Water and delivers it to homes and businesses. The cost of this water supply is passed through to customers at cost. SJWC is filing Advice Letter 577 to recover the pass-through increase.

How could this affect my water bill?

If SJWC's rate request is approved by the CPUC, the monthly bill for the typical residential customer with a 3/4-inch meter using 11 Ccf per month would increase by approximately \$5.76 (or 5.79%) from \$99.43 at present rates, to \$105.19 starting July 1, 2022. This amount will be reflected on customers' bills through the quantity charges as shown below. A comparison of the current and the proposed quantity rates is as follows:

How does the rest of this process work?

This Advice Letter will be reviewed by staff in the Water Division of the CPUC. They will determine if the request is reasonable and determine if modifications are necessary.

Protests and Responses to Advice Letter #577

The reasons for the protest can be one of the following:

- 1) The utility did not properly serve or give notice of the advice letter;
- 2) The relief requested in the advice letter would violate statute or CPUC order, or is not authorized by statute or CPUC order on which the utility relies;
- 3) The analysis, calculations, or data in the advice letter contain material error or omissions;
- 4) The relief requested in the advice letter is pending before the CPUC in a formal proceeding;
- 5) The relief requested in the advice letter requires consideration in a formal hearing, or is otherwise inappropriate for the advice letter process; or
- 6) The relief requested in the advice letter is unjust, unreasonable, or discriminatory (provided that such a protest may not be made where it would require re-litigating a prior order of the CPUC).
