

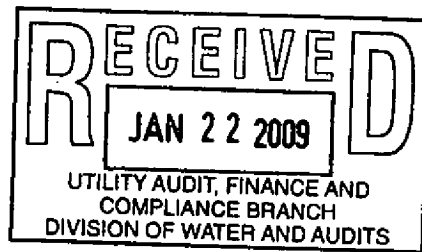

(1) This Schedule F - Income Statement, is not an actual statement of revenues and expenses for this period. It is a recapitulation of the Summary of Earnings, Test Year 2008, during 2007, at Utility Present Rates. It was not possible to compile the actual statement due to the company going into receivership at October 1, 2007. The receiver, Weeks Drilling, upon request by Staff, declined to be able to provide any other details for this period. The company said it could not receive information from the original owner. It is expected that Weeks will be providing its own income statement for 2008, and for actual activity incurred.
