


Summary of annual low-income program discounts, surcharges and itemized low-income program costs: Qualifying customers receive a fixed discount of \$9.82 per month on their monthly service charge.

Specify which costs are included in rates, if any: There are no costs included in base rates. In the Los Angeles County division, forecasted costs are recovered through a \$0.2158/Ccf surcharge billed to non-CARW customers, subject to later true-up. In the Fontana Water Company division, forecasted costs are recovered through a \$0.2389/Ccf surcharge billed to non-CARW customers, subject to later true-up.

At year end, 20,878 customers or 53.4% of the adopted 39,072 residential single-family customers with a 1-inch or smaller meter qualified for the CARW program in the Los Angeles County division, and 24,509 customers or 57.1% of the adopted 42,932 residential single-family customers with a 1-inch or smaller meter qualified for the CARW program in the Fontana Water Company division. At year end, the total undercollected balance in the CARW balancing accounts was \$968,863.
