## **Twin Valley, Inc. Supplemental Statement**

In 2018, the California State Water Resources Control Board, Division of Drinking Water (Water Board) initiated proceedings in the Santa Clara County Superior Court to place the Twin Valley, Inc. water system (TVI Water System) in Receivership. In Case No. 18CV321727, the Court initially appointed Marlene F. Demery as Receiver.

Ms. Demery, as Receiver, entered into a contract with Cypress Water Services, Inc. to operate the TVI Water System. Cypress Water Services, Inc. has operated the TVI Water System since that time. Miles Farmer is the President of Cypress Water Services, Inc.

In 2022, Ms. Demery indicated her intention to retire as Receiver for the TVI Water System. The Water Board contacted Timothy Guster, then Vice President and General Counsel of Great Oaks Water Company and requested that he serve as the next Receiver. Mr. Guster agreed, and on September 16, 2022, the Court issued an Amended Order Substituting Receiver, which appointed Mr. Guster as Receiver. Mr. Guster served as Receiver without compensation.

Mr. Guster, as Receiver, extended the contract with Cypress Water Services, Inc. for the operation of the TVI Water System. Mr. Guster secured a commitment from Central States Water Resources, Inc. to purchase the assets of the TVI Water System and, on August 17, 2023, the Court issued an Order to Approve Agreement for Sale of Utility System, with Central States Water Resources, Inc. as the purchaser.

Central States Water Resources, Inc., despite repeated requests from the Receiver, took no visible action to complete the purchase agreement in 2023. In February 2024, the Receiver was advised by counsel for Central States Water Resources, Inc. that the purchase agreement would not be honored. No reason was provided.

Mr. Guster advised the Water Board that he intended to retire as Receiver (following his retirement from Great Oaks Water Company). On July 23, 2024, the Court issued a Third Amended Order Substituting Receiver, appointing Cypress Water Services, Inc. as Receiver.

Because the TVI Water System is in Receivership and original accounting records are not available, certain information normally required for an Annual Report cannot be provided. No information is available for the following portions of the Annual Report:
