10 A. INTRODUCTION

The document entitled "Protocols and Procedures For the Verification of Costs, 11 Benefits, and Shareholder Earnings From Demand-Side Management Programs" 12 ("Protocols"), $\frac{1}{2}$ identifies the protocols and procedures currently used by the four major 13 California investor-owned utilities to document and verify the costs and benefits of 14 demand-side management ("DSM") program activities for Program Years 1994 through 15 Southern California Gas Company ("SoCalGas") has followed the Protocols in 16 1997. the preparation of this year's Demand-Side Management and Energy Efficiency 17 Programs Annual Summary ("Annual Summary") which is included with, and made a 18 part of, SoCalGas' 2000 Annual Earnings Assessment Proceeding ("AEAP") Application 19 as Exhibit SoCalGas-2. Section VIII of the Annual Summary addresses SoCalGas' 20 shareholder earnings claims related to the performance of SoCalGas' 1997 and 1995 21 DSM programs. Section VIII has been prepared in accordance with the Sixth Edition of 22 the DSM Reporting Requirements Manual dated December 1996, and the Protocols. A 23 draft Chapter VIII was provided to the California Public Utilities Commission's 24 ("Commission") Office of Ratepayer Advocates ("ORA") on April 17, 2000. 25

26 Pursuant to Tables 1, 2, and 10 of the Protocols (pages 4, 5, and 27, 27 respectively), the shareholder incentive claim which SoCalGas is making in this 2000

As adopted by California Public Utilities Commission Decision 93-05-063; revised January 1997 pursuant to Decisions 94-05-063, 94-10-059, 94-12-021, 95-12-054, and 96-12-079.

AEAP is for: (1) the performance of Program Year 1997 ("PY1997") DSM programs, limited to the first earnings claim under the earnings distribution schedule for PY1997 commitments paid in calendar year 1999, (2) the second earnings claim for the performance of PY1997 DSM programs under the earnings distribution schedule for PY1997 commitments paid in calendar year 1998, and (3) the third earnings claim for the performance of its Program Year 1995 ("PY1995") DSM programs.

The PY1997 first earnings claim represents the first installment of the projected lifecycle shareholder earnings that may be claimed by SoCalGas for its performance of 1997 DSM programs. This claim is for PY1997 program commitments made in 1997, which were paid out in 1999. The earnings claim is being made pursuant to Commission Decisions (D.) 97-09-117 and 97-12-103.

"Lifecycle earnings" are the total amount of the shareholder earnings that may eventually be recovered by SoCalGas following the completion and verification of all required impact studies in subsequent years. The first earnings claim is based on actual, verified program costs and participation levels and forecasted net impacts per unit, and is equal to 25% of SoCalGas' projected lifecycle shareholder earnings for its 1997 DSM programs.

The PY1997 second earnings claim represents the second installment of the updated projected lifecycle shareholder earnings that may be claimed by SoCalGas for its PY1997 program commitments that were installed in 1998.

The PY1995 third earnings claim represents the third installment of the updated projected lifecycle shareholder earnings that may be claimed by SoCalGas for its PY1995 DSM programs.

Discussed below are SoCalGas' 1997 and 1995 DSM programs. SoCalGas' first earnings claim for 1997 DSM program performance occurring in 1999 results in projected lifecycle shareholder earnings of \$145,940, which provide a first earnings claim in this 2000 AEAP of \$36,485 (25% of \$145,940).

The second earnings claim for 1997 DSM program performance occurring in 1998 is based on a revised lifecycle earnings of \$1,390,636, which provides a second earnings claim in this AEAP of \$347,659 (50% of \$1,390,636 less the first earnings claim for this program performance).

5 The third earnings claim for SoCalGas' 1995 DSM program's performance 6 results in a revised 1995 DSM program performance projected lifecycle shareholder 7 earnings for SoCalGas' energy efficiency program and Direct Assistance program. This 8 revised lifecycle shareholder earnings amount is \$3,479,000, producing a third earnings 9 claim in this 1999 AEAP of \$869,792 (75% of \$3,479,000 less the total of previous 10 earnings claims for 1995 DSM programs).

Therefore, in this Application, SoCalGas requests that the Commission grant SoCalGas authority, effective January 1, 2001, to increase SoCalGas' authorized gas revenue requirements as necessary to permit SoCalGas to recover \$36,485 for its first earnings claim for PY1997, \$347,659 for its second earnings claim for PY1997, plus \$869,792 for its third earnings claim from PY1995.

In addition, SoCalGas requests that total interest of \$267,544 be accrued on these earnings claims, as stipulated in D.94-10-059, page 113. SoCalGas also requests an additional sum for franchise fees and uncollectibles related to each claim, totaling \$51,824. Accordingly, the year 2001 total authorized revenue requirement increase requested in this 2000 AEAP for PY1994-97 program activity is \$1,573,304.

21B.SUMMARY OF PY1997 PROGRAMS AND PERFORMANCE FOR CALENDAR22YEAR 1999: FIRST EARNINGS CLAIM

Included in Appendix B of SoCalGas' Application are PY1997 first earnings claim summary Tables E-1, E-2, and E-3. These tables include first-year earnings claims for PY1997 projects committed in 1997 and completed in 1999. SoCalGas' witness, Pamela Brown, is sponsoring the DSM Annual Summary (Exhibit SoCalGas-2) to the extent it supports those earnings claim summaries. The 1997 DSM incentive

mechanisms were adopted by D.94-10-059, entitled "Interim Opinion on DSM
Shareholder Incentives: Implementation Phase."

SoCalGas is claiming first-year earnings for the PY1997 Energy Edge program. This program is subject to the shared savings incentive mechanism. Under this incentive mechanism, shareholder earnings are calculated at 30% of a performance earnings basis. The performance earnings basis for this mechanism is defined as twothirds of the Total Resource Cost net benefits plus one third of the Utility Cost net benefits. The shared savings incentive mechanism is defined in detail in D.94-10-059, beginning on page 18.

Accomplishments in this program are described in detail in the DSM Annual Summary (Exhibit SoCalGas-2). In total, SoCalGas' 1997 first-year earnings claim for DSM program performance completed in 1999 under the adopted incentive mechanisms produces a projected lifecycle shareholder earnings claim of \$145,940; the total first earnings claim under this incentive mechanism is \$36,485.

SUMMARY OF PY1997 PROGRAMS AND PERFORMANCE FOR CALENDAR YEAR 1998: SECOND EARNINGS CLAIM

Included in Appendix C of SoCalGas' Application are PY1997 second earnings
claim summary Tables E-1, E-2, and E-3. These tables include second-year earnings
claims for PY1997 projects committed in 1997 and completed in 1998 for the Energy
Edge program. Ms. Brown is sponsoring the DSM Annual Summary (Exhibit
SoCalGas-2) to the extent it supports those earnings claim summaries. The 1997 DSM
incentive mechanisms were adopted by D.94-10-059, entitled "Interim Opinion on DSM
Shareholder Incentives: Implementation Phase."

In this application, SoCalGas is deferring its request for the second earnings claim associated with its Residential Pilot Bidding program. Due to a delay in the receipt of information from the program's contractor, a review of the information and resolution of issues could not be completed in time for this AEAP filing. SoCalGas will

submit its respective earnings claim in the 2001 AEAP or include it in the appropriate
AEAP consistent with the earnings distribution schedule for third earnings claims.

SoCalGas' second earnings claim for its 1997 DSM programs represents the
 second installment of the projected lifecycle shareholder earnings for those programs
 as revised.

The second earnings claim for PY1997 is \$347,659. This amount represents the
difference between 50% of the revised projected lifecycle shareholder earnings for
PY1997 (50% of \$1,391,000) and the previous earnings claim for PY1997.

9 D. SUMMARY OF PY1995 PROGRAMS AND PERFORMANCE: THIRD 10 EARNINGS CLAIM

Included in Appendix D of SoCalGas' Application are PY1995 earnings claim summary Tables E-1, E-2, and E-3 pertaining to SoCalGas' third earnings claim. Ms. Brown is sponsoring the DSM Annual Summary (Exhibit SoCalGas-2) to the extent it supports those earnings claim summaries. The 1995 DSM incentive mechanisms were adopted by D.94-10-059, entitled "Interim Opinion on DSM Shareholder Incentives: Implementation Phase."

17 SoCalGas' third earnings claim for its 1995 DSM programs represents the third 18 installment of the projected lifecycle shareholder earnings for those programs as 19 revised.

The third earnings claim for PY1995 is 869,792 (which includes the following programs: REMS, CEMS, IEMS, CER, and DAP^{2/}). This amount represents the difference between 75% of the revised projected lifecycle shareholder earnings for PY1995 (75% of 3,479,000) and the sum of the previous earnings claims for PY1995.

In conclusion, SoCalGas respectfully requests that the Commission approve
 SoCalGas' 2000 AEAP application within a time frame that will allow SoCalGas to
 implement all related authorized revenue adjustments effective January 1, 2001.

I. SOCALGAS SHAREHOLDER EARNINGS CLAIM FROM 1999 ENERGY EFFICIENCY PROGRAMS

A. INTRODUCTION

The purpose of this testimony is to present and support SoCalGas' shareholder earnings claim for SoCalGas' program year (PY) 1999 energy efficiency programs,

SoCalGas filed its Advice Letter ("AL") 2760-G requesting approval of its 1999 Energy Efficiency program plans, budgets, and performance incentive award mechanism on November 16, 1998 as required by the Assigned Commissioner's Ruling in Rulemaking 98-07-037 dated September 23, 1998. In order to avoid any disruption in program delivery due to the potential delay in the approval of its proposed PY1999 programs, SoCalGas filed AL 2766 -G that requested authorization to continue in 1999 the Residential New Construction program and continue program planning and design activities for the 1999 programs. Resolution E-3581, issued December 17, 1998, granted authorization to undertake these activities through the end of February 1999.

On December 17 and 21, 1998, the California Board for Energy Efficiency ("CBEE") filed preliminary and final recommendations and comments on its review of the four major California investor-owned utilities' ("Utilities") advice letters on their PY1999 Energy Efficiency program proposals. Subsequently, the utilities' submitted comments in response to the CBEE's comments and provided an alternate performance incentive award mechanism on January 13, 1999.

On February 18, 1999, the Commission issued ResolutionE-3589 authorizing month-to-month funding and program delivery, and permitted pre-implementation tasks

necessary for timely deployment of the 1999 programs.

SoCalGas' AL 2760-G PY99 program area budget and revised program budget and January 13, 1999 alternative performance incentive award mechanism for PY1999 Energy Efficiency programs were authorized by Resolution E-3578 issued on March 18, 1999. In addition, the resolution adopted uncontested Policy Rule changes as Interim, and also ordered the utilities to file supplemental advice letters providing additional details on the program descriptions by March 25, 1999. Resolution E-3592, issued on April 1, 1999, adopted the final PY1999 utility programs, including plans, budgets, and incentive mechanisms. Furthermore, it adopted other changes to the Policy Rules.

Shareholder Earnings Claim

SoCalGas' 1999 Energy Efficiency (non-low-income) program performance results in shareholder earnings of \$2,805,395. SoCalGas requests that all of the earnings for PY1999 Energy Efficiency program performance be awarded in a single payment to be recovered in rates in calendar year 2001. Therefore, in this Application, SoCalGas requests that the Commission grant SoCalGas authority, effective January 1, 2001, to increase SoCalGas' authorized gas revenue requirements as necessary to permit SoCalGas to recover \$2,805,395 for its earnings claim for PY1999. SoCalGas further requests interest related to this claim of \$144,649 as stipulated in D.94-10-059, page 113. SoCalGas also requests franchise fees and uncollectibles ("FF&U") related to this claim of \$28,615. Accordingly, the year 2001 total authorized revenue requirement increase for PY1999 earnings requested in this 2000 AEAP is \$2,978,659.

B. SUMMARY OF PY1999 ENERGY EFFICIENCY PROGRAMS AND PERFORMANCE

Included in Appendix A of SoCalGas' Application are PY1999 earnings claim summary Tables E-1, E-2, E-3, and E-4. SoCalGas' witness, Pamela Brown, is sponsoring the Energy Efficiency Programs Annual Report (Exhibit SoCalGas-2) to the

extent it supports those earnings claim summaries. The 1999 Energy Efficiency incentive mechanism was adopted by Resolution 3578. The requirements of the mechanisms and the calculation of the shareholder awards pursuant to each mechanism are described in Section VIII of the Energy Efficiency Programs Annual Report. Attachment A to this testimony describes the milestone results for each program individually, while below is an overall summary of SoCalGas' performance on the milestones.

Performance awards are divided into the four categories approved by the CPUC: Base Award, Administrative and Program Processes, Market Changes/Effects, and Aggressive Implementation. Failure to achieve an award in any single category does not preclude achieving awards in other categories. The tiers are not additive. Failure to meet level 1 defaults to level 2. The maximum total award from SoCalGas efforts has been capped at \$2,991,000.

Base Award

To be eligible for the base award, the following criteria were met:

Program Definitions: For its November 16, 1998 Advice Letter, SoCalGas utilized the CBEE's new program definitions (program areas, programs, program elements, and intervention strategies). These new definitions were used to report on and track the programs throughout the year.

SoCalGas provided revised program descriptions using the CBEE's new program definitions to the Energy Division, the CBEE, and the public on March 25, 1999.

Reporting: Program activities, status reports, etc., were to be reported in the following manners: (1) Using two systems—the "old" program definitions used for 1998 programs, and the CBEE's new program definitions; and (2) Administration vs. implementation—program expenditures would be tracked using these categories, once definitions were determined that were clear and consistent for the programs.

SoCalGas provided its PY99 quarterly status reports, which included descriptions of program progress and expenditures, to the CBEE using the CBEE's new program definitions. In addition, SoCalGas has reported its PY99 program accomplishments in its 2000 EE Annual Summary, using the program definitions for the 1998 programs consistent with SoCalGas' 1999 EE Annual Summary.

The Energy Division conducted a workshop on March 8 and 9, 1999, to address revisions to the existing Reporting Requirements Manual, including the definition of "administration vs. implementation" costs. The workshop report issued on April 2, 1999 did not include recommendations to clearly define "administration" and "implementation" costs. Therefore, SoCalGas did not track program expenditures according to these categories. SoCalGas' program costs, however, are reported according to the current program cost categories consistent with the Reporting Requirements Manual in its 2000 EE Annual Summary, which includes categories for "administration," "program incentives," and "other."

There are ten milestones in the Base Award portion of the 1999 award mechanism. Each milestone has two target dates (level 1 and level 2) for completion. The first, more aggressive date, is designated the level 1 date, while the second date is designated the level 2 date. To achieve a first tier award, eight of the ten milestones must meet the respective level 1 dates; to achieve a second tier award, seven of the ten milestones must meet the respective level 2 dates. A first tier award would earn SoCalGas \$957,000; a second tier award would earn \$670,000.

In 1999, SoCalGas achieved ten of ten first level milestones, earning the first tier award of \$957,000.

Program Processes Award

There are nine milestones in the Program Processes Award portion of the 1999 award mechanism. Each milestone has two target dates for completion. The first, more aggressive date, is designated the level 1 date, while the second date is

designated the level 2 date. To achieve a first tier award, seven of the nine milestones must meet the respective level 1 dates; to achieve a second tier award, six of the nine milestones must meet the respective level 2 dates. A first tier award would earn SoCalGas \$957,000; a second tier award would earn \$670,000.

In 1999, SoCalGas achieved eight of nine first level milestones, earning \$957,000.

Market Changes/ Effects Award

There are four milestones in the Market Changes/Effects Award portion of the 1999 award mechanism. Each milestone has a measure target for completion. To achieve a first tier award, 100% of the measure target must be met; to achieve a second tier award, 70%-99% of the measure target must be met. Each program that meets the first tier measure target will earn \$119,750 (\$479,000 if all four measure targets are met). Each program that meets the second tier measure target will earn \$13,750 (\$335,000 if all four measure targets are met). Each program that meets are met. Each program and measure target are determined independently of the others.

In 1999, SoCalGas achieved two of the first tier awards (Residential Upstream – Appliance (water heater) and Statewide Residential Upstream – Appliance (clothes washer)) earning \$239,500. SoCalGas achieved no second tier awards, and failed to meet the measure target in two programs (Energy Advantage New Home and Small Nonresidential Comprehensive Efficiency Retrofit (HVAC)). Total awards under the Market Changes/Effects award are \$239,500.

Aggressive Implementation Award

The Aggressive Implementation Award is achieved only after spending/committing 70% of the budget within a program area. The award increases linearly to the maximum level set at the 90% spending/commitment target. Program area awards will be reduced by 10% for each program (within the program area) that spent less than 50% of the authorized budget. The maximum total award is \$748,000.

In the Residential Program Area, the earnings that can be achieved range between \$179,206 and \$256,000. Spending/commitment in this area represents 72.04%, earning \$187,034. No reductions to these earnings are required as all programs within the program area achieved at least a 50% spending/commitment level.

In the Non-residential Program Area, the earnings that can be achieved range between \$256,900 and \$367,000. Spending/commitment in this area represents 85.07%, earning \$339,861. No reductions to these earnings are required as all programs within the program area achieved at least a 50% spending/commitment level.

In the New Construction Program Area, the earnings that can be achieved range between \$87,500 and \$125,000. Spending/commitment in this area represents 105.3%, earning \$125,000. No reductions to these earnings are required as all programs within the program area achieved at least a 50% spending/commitment level.

Total Earnings Claim

With the Base Award of \$957,000, Program Process Award of \$957,000, Market Changes/Effects Award of \$239,500, and Aggressive Implementation Award of \$651,894, SoCalGas is requesting PY1999 Energy Efficiency program earnings totaling \$2,805,395, which is less than the cap of \$2,991,000. With interest and FF&U, the total PY1999 Energy Efficiency revenue requirement is \$2,978,659.

1 C. CONCLUSION

In conclusion, SoCalGas respectfully requests that the Commission approve SoCalGas' 2000 AEAP application within a time frame that will allow SoCalGas to implement all related authorized revenue adjustments effective January 1, 2001.

1999 Program Milestones for Southern California Gas Company

All milestone verification documents are filed in accordance with the following numbering protocol. All base milestones are identified with a "B" plus a number; all process milestones are identified with a "P" plus a number; all market effects milestones are identified with an "M" plus a number. The aggressive implementation milestone is presented in a table.

Base Award

 1^{st} tier award (level 1) – meet eight of ten level 1 milestones to earn \$957,000 2^{nd} tier award (level 2) – meet seven of ten level 2 milestones to earn \$670,000

B1 Milestone

Milestone Description

This base milestone (Residential Program Area –Residential Retrofit and Renovation Program, Statewide Residential Energy Efficiency Contractor Program) was to complete a draft statewide program design based on workshop results. To achieve a first tier award, the draft was to be completed by March 15, 1999; to achieve a second tier award, the draft was to be completed by April 15, 1999.

Milestone Verification

An e-mail survey of stakeholders and other members of the public was conducted prior to the workshop held on January 14, 1999. This approach enabled those who were unable to attend the workshop to provide comments on program design. Focus groups were then held on February 8 (SDG&E), February 9 (SCE), February 10 (SoCalGas) and February 18 (PG&E). The draft statewide program design document was then completed, dated March 15, 1999, and demonstrates that SoCalGas met the first tier award eligibility requirement for this milestone.

Milestone Documentation

• A draft statewide program design document dated March 15, 1999.

B2 Milestone

Milestone Description

This base milestone (Residential Program Area –Residential Retrofit and Renovation Program, Statewide Residential Energy Efficiency Contractor Program) was to have the program "on the street." "On the street" means that the program has been advertised to customers and that systems are available to process customer/contractor requests and, in the case of incentive efforts, issue checks to customers/contractors. To achieve a first tier award, the above activities were to occur by May 1, 1999; to achieve a second tier award, these activities were to occur by June 1, 1999.

Milestone Verification

SoCalGas conducted program implementation workshops, used media advertising and put internal systems in place to process customers' vouchers/applications. I. SOCALGAS SHAREHOLDER EARNINGS CLAIM FROM 1999 and 1998 LOW-INCOME ENERGY EFFICIENCY PROGRAMS

A. INTRODUCTION

The purpose of this testimony is to present and support Southern California Gas Company's (SoCalGas) shareholder earnings claim for SoCalGas' program year (PY) 1999 low-income energy efficiency ("LIEE") program¹, and to request a change to the collection schedule for earnings associated with the PY1998 Direct Assistance program (DAP).

SoCalGas filed Advice No. 2631 requesting approval of its 1998 DAP program plans and budgets. The Commission approved SoCalGas' advice letter through Resolution E-3515. Subsequently, the Commission issued D.98-06-063, which modified Resolution E-3515. Advice No. 2748 sought approval of SoCalGas' 1999 DAP program plans and budgets. The Commission approved SoCalGas' program efforts through Resolutions E-3583, E-3585 and E-3586.

Shareholder Earnings Claim

The earnings associated with SoCalGas' 1999 Direct Assistance Program are \$205,031. SoCalGas requests that the earnings from the PY1999 Direct Assistance Program be awarded in two payments of \$102,515, the first of these payments to be awarded and to be recovered in rates in calendar year 2001. Therefore, in this Application, SoCalGas requests that the Commission grant

SoCalGas authority, effective January 1, 2001, to increase SoCalGas' authorized gas revenue requirements as necessary to permit SoCalGas to recover \$102,515 for its earnings claim for PY1999 LIEE programs. SoCalGas further requests interest related to this claim of \$5,286, as stipulated in D.94-10-059, page 113. SoCalGas also requests franchise fees and uncollectibles ("FF&U") related to this claim of \$1,046. Accordingly, the year 2001 total authorized revenue requirement increase for PY1999 LIEE earnings requested in this AEAP is \$108,847.

In addition, SoCalGas requests collection of the second earnings claim for its PY1998 LIEE program of \$108,152 plus interest of \$10,987 and FF&U of \$7,092. Accordingly, the year 2001 total authorized revenue requirement increase for PY1998 LIEE earnings requested in this AEAP is \$126,231.

B. PY1998 LOW-INCOME ENERGY EFFICIENCY PROGRAMS

SoCalGas' PY1998 LIEE lifecycle earnings claim is \$216,304 as requested and documented in the 1999 AEAP filing, A.99-05-005. SoCalGas met the minimum performance requirement for the mandatory DAP program in order to qualify for earnings.

The 1999 AEAP Case Management Statement of the Office of Ratepayer Advocates, Pacific Gas & Electric Company ("PG&E"), San Diego Gas & Electric Company ("SDG&E"), Southern California Edison Company ("SCE"), SoCalGas, and Residential Energy Efficiency Clearing House, Inc. ("REECH") filed with the Commission on November 2, 1999, describes the agreement of the aforementioned parties regarding the collection of the PY1998 LIEE shareholder incentives. The parties agreed that the PY1998 Utility shareholder incentives would be collected in two installments: 50% to be authorized in the 1999 AEAP for collection in rates in 2000; and the remaining 50% to be authorized after the

completion of the PY1998 first year statewide load impact evaluation and submitted in the 2000 AEAP for collection in rates in 2001.

SoCalGas jointly filed with PG&E, SCE, and SDG&E the first-year load impact evaluation of the PY1998 LIEE program on April 17, 2000.

Therefore, consistent with the 1999 AEAP Case Management Statement, SoCalGas' second earnings claim for the PY1998 LIEE program is \$108,152, plus interest from July 1, 1999 through December 2000, franchise fees, and uncollectibles in the amount of \$18,079, for a total request of \$126,231.

C. PY1999 LOW-INCOME ENERGY EFFICIENCY PROGRAMS

SoCalGas' PY1999 LIEE program lifecycle earnings claim is \$205,031. The earnings are allocated on the non-mandatory component of the LIEE program including SoCalGas' low-income education program and subject to meeting the minimum performance threshold of 75% of forecasted units. SoCalGas met the minimum performance requirement for 1999 earnings by weatherizing 25,238 homes, exceeding 100% of the forecasted 25,000 homes.

SoCalGas proposes to collect the PY1999 LIEE earnings in two earnings claims: 50% to be authorized in the 2000 AEAP for collection in rates in 2001; and the remaining 50% to be authorized in the 2001 AEAP for collection in rates in 2002. This two-year collection proposal is consistent with the "Joint Recommendation On The Program Year 2000 Low-Income Energy Efficiency Shareholder Incentive Mechanism" submitted on November 10, 1999, and identified as Exhibit 66 in Phase 2 of the 1999 AEAP. Although both the PY1999 AEAP Case Management Statement and the Joint Recommendation on the PY2000 LIEE shareholder mechanism require the submission of a study on the respective program years for the second-year claim, SoCalGas does not believe that there is any meaningful information to be gained by requiring that an

additional study should be completed.

Therefore, SoCalGas' first earnings claim for the PY1999 LIEE program is 50% of the total lifecycle earnings of \$205,031, or \$102,515, plus interest from July 1, 2000 through December 2001, and FF&U, in the amount of \$6,332, for a total request of \$108,847.

D. CONCLUSION

In conclusion, SoCalGas respectfully requests that the Commission approve SoCalGas' 2000 AEAP application within a time frame that will allow SoCalGas to implement all related authorized revenue adjustments effective January 1, 2001.
