ADMINISTRATIVE LAW JUDGE'S RULING REGARDING NOTICE OF AVAILABILITY, PUBLIC PARTICIPATION HEARINGS, COMMENTS TO THE WORKSHOP REPORT, AND SCHEDULING OF PREHEARING CONFERENCE

On January 6, 2000, the Commission instituted a rulemaking into the implementation of Assembly Bill (AB) 1149, (Stats. 1999, Ch. 844) which requires the Commission to conduct a study as to ways to amend, revise, and improve the rules for the conversion of existing overhead electric and communications lines to underground service. The Commission must submit a report to the Legislature on this study by January 1, 2001. To conduct the study, the Commission bifurcated the process into phases: Phase 1 involves workshops conducted by the Energy Division and six Public Participation Hearings (PPHs); and Phase 2 will focus on narrowing the issues into a recommendation to the Commission and a report to the Legislature. The workshops were designed to encourage discussion by the interested stakeholders on which issues should be addressed in this rulemaking and in what priority. Respondent electric and communications facilities have been active participants in the workshops.

The Energy Division will now prepare a workshop report. The Commission will allow any party wishing to file comments on what should or should not be considered in this report to do so by April 25, 2000. Replies, if any, should be filed by May 8, 2000. The draft workshop report will be circulated for comments in June 2000. The final report is expected in July 2000.

The Commissioner and I will begin Phase 2 of the study once the six scheduled PPHs are complete. We have scheduled a Prehearing Conference (PHC) for August 1, 2000, at 10:00 a.m., and the Commissioner will issue a scoping memo in advance of that date. The scoping memo will incorporate the information from the Workshop Report as well as from the PPHs so the Commission can advise the Legislature what improvements or revisions the stakeholders, respondents, and the public want to the undergrounding conversion rules. The scoping memo will provide the focus for Phase 2 of the Commission's study.

Master Data Requests

The workshops have resulted in five agreed upon Master Data Requests. By early April 2000, Respondents should have stated when they will respond to all or parts of these Data Requests. Respondents San Diego Gas & Electric Company, Southern California Edison Company, and Pacific Gas and Electric Company should produce their respective project by project cost data.

Notice of Availability

Because of the enormity of many of the data responses and the size of the service list, I will relieve Respondents from the obligation to serve all parties, and, pursuant to Rule 2.3(c)¹ will allow Respondents to serve a Notice of

Availability in lieu of all or part of the document. If Respondents avail themselves of the Notice of Availability, they must comply with Rule 2.1(a) and serve all parties, both those on electronic service and those on mail service, with the document's exact title, indicate which data request is being answered, and summarize the contents of the response. The Notice must state that a copy of the document will be served at the request of the party receiving the Notice and must state the name, telephone number, facsimile transmission number, if any, and e-mail address (if available), of the person to whom such requests should be directed. The party sending the Notice must serve any party making such request within one business day after receipt of the request.

The original document and copies filed with the Commission, including the Energy Division, must be complete (see Rule 2.5). A copy of the complete document must be served on any party who has previously informed the serving party of its desire to receive a complete copy. The Commissioner and I do not need to receive the Data Requests or responses.

Public Participation Hearings

Six PPHs have been noticed for the purpose of gathering information from the public on undergrounding and ways to amend, revise, and improve the existing rules. The PPHs are scheduled as follows:
