Cliff Rochlin, Market Advisor for SoCalGas, was also present. Swartz stated that SoCalGas supports the ALJ's proposed decision and Cmmr. Duque's alternate decision. Swartz further stated that it is the ISO's responsibility to determine whether the upgrades are necessary and plan for the entire transmission grid. Rochlin stated that the ISO has designed an integrated transmission planning process with stakeholders for proposing, planning, constructing, and recovering the costs of transmission related projects. Swartz stated that the ISO must address the cost effectiveness of the upgrades, reliability and the impact on transmission rates.
