Hubbard stated that the opinion written by the Energy Division denied SDG&E's request in this proceeding, despite numerous meetings that had taken place with the Energy Division staff to try to alleviate their concerns. Hubbard stated that Cmmr. Neeper was sponsoring an alternate opinion, which approves SDG&E's request subject to conditions, some of which had been discussed with Energy Division staff during previous meetings. Hubbard, referencing the attached handout, stated that AB1890 demonstrated a state policy that should allow the utilities to use these financial instruments. Hubbard stated that the concern over market power issues were unfounded as SDG&E has very little generation and no incentive to "game" the PX price as raising the PX price would only serve to extend the recovery of stranded costs. Hubbard lastly stated that SDG&E had agreed to an 80/20 ratepayer/shareholder sharing of risks and benefits, rather than SDG&E's original proposal of 100% to ratepayers, in order to address cost control concerns; in addition, SDG&E agreed to yearly temporal limits and that no derivative transactions would be entered into which would extend beyond 3/31/02. Bowman stated that SDG&E is concerned about the restriction that the company only enter into transactions with companies whose credit rating is equal to or above that of SDG&E. Bowman added that SDG&E is concerned about the restriction would eliminate SDG&E's ability to enter into transactions with firms such as Enron, Natural Gas Clearinghouse, El Paso Natural Gas, and a number of other established market participants. Bowman added that the alternate opinion limits derivative transactions to those traded on exchanges regulated by the Commodity Futures Trading Commission. Bowman stated that SDG&E needs to be able to edge gas prices at San Juan or the California border and electric prices at the Power Exchange as well.

Materials (attached to notice), consisting of a handout titled "Financing Information Regarding the California Power Exchange Corporation" were used. McDonald stated that the total projected development costs for the PX is now \$85 million. McDonald stated that lending issues exist for the PX due to the lack of access to equity capital and to the uncertainty of volume from PX participants in future years. Loughridge stated that the PX needs: 1) additional funding before the end of 1997 in order to perform the necessary start-up functions by January 1, 1998; 2) the loan provided for under the Trust Agreement to be extended by \$26 million for the PX; and 3) the proposed rate design, which is based on an up-front payment of the loan extension, approved by the Federal Energy Regulatory Commission (FERC). Ritchey stated that the PX views its primary goal as satisfying customers and recognizes that the PX must earn its place in the marketplace to become the provider of choice. Ritchey added that in order to meet its mandated role and serve its customers, the PX must get started in the fist place. The Utilities stated that the PX is rewired to deal with such regulatory functions as overgeneration protocols and must-take contracts, as well as abide by tariffs and rules ordered by the FERC. The Utilities stated that they will seek to recover the PX and ISO implementation costs, and that such treatment will be requested under a petition for modification of decisions D96-08-038 and D96-10-044.

Linsey explained the implications of the "to the extent" language, which are as follows: 1) If there is not a credible way to determine the impact on headroom, Section 376 recovery should not be allowed, and 2) If the transmission investments are good investments, the decrease in generation costs should more than offset the increase in generation costs, hence, Edison's ability to recover its generation-related costs would not be impaired, but would be enhanced.
