Summary: On October 31, 1997, Jim Thompson, Chief Operating Officer of Catalina Clipper, LLC (Catalina Clipper), sent a letter (attached to notice) to Cmmrs. Conlon, Knight, Neeper, Duque, and Bilas. A copy was also sent to ALJ Ryerson. The letter states that the Commissioners did not seem to be aware that Catalina Clipper is presently constructing a new 450 passenger capacity high-speed passenger vessel for delivery in June, 1998 for use in the Long Beach—Avalon market. The letter further stated that Catalina Cruises had lost money for years because it was not willing to make the investment in highspeed vessels in order to effectively compete. The letter stated that Catalina Clipper has purchased the assets of Catalina Cruises with the intent of running a competitive and profitable business and to do that they will offer a high-speed service as well as a \$23 slow boat service. The letter stated that with the new boat, there will be significant competition in the marketplace and Catalina Clipper's passenger capacity will increase by more than 20%.
