GLOSSARY

After January 1, 1998, the California Public Utilities Commission is required by statute (SB 960) to categorize each case that comes before it. There are three categories, quasi-legislative, adjudicatory and ratesetting. If a case does not require hearings before it is resolved, the case is removed from the SB 960 category requirements. The legend below shows the abbreviation for each of the categories and provides a brief explanation.

- Q **Quasi-legislative** proceedings are proceedings that establish policy or rules (including generic ratemaking policy or rules) affecting a class of regulated entities, including those proceedings in which the Commission investigates rates or practices for an entire regulated industry or class of entities within the industry.
- A **Adjudicatory** proceedings are: (1) enforcement investigations into possible violations of any provision of statutory law or order or rule of the Commission; and (2) complaints against regulated entities, including those complaints that challenge the accuracy of a bill, but excluding those complaints that challenge the reasonableness of rates or charges, past, present, or future.
- RS **Ratesetting** proceedings are proceedings in which the Commission sets or investigates rates for a specifically named utility (or utilities), or establishes a mechanism that in turn sets the rates for a specifically named utility (or utilities). Ratesetting proceedings include complaints that challenge the reasonableness of rates or charges, past, present, or future.
- N/A Removed from the SB 960 category requirements.

Subscription Notice for Draft Agenda Items

In compliance with Public Utilities Code Section 311.5, parties who wish to subscribe to receive draft agenda items may do so by writing to the Public Utilities Commission; Attention: Poly Arca, Room 1003; 505 Van Ness Avenue; San Francisco, CA 94102; or by calling (415) 703-1798. The cost for a one-year subscription to the entire public agenda package (which excludes Executive Session materials) is \$1,000. You may also order a partial agenda package (energy agenda items only or telecommunication agenda items only) at the cost of \$500 per year. The package you receive via mail will include only those agenda items available at the time of the agenda distribution date, which is usually 10 to 12 days prior to the Commission meeting. Summary: On July 10, 1998 seventeen (17) parties met for one hour with Commissioner Knight and advisor, Dorothy Duda, in an all party meeting at PUC headquarters initiated by the Office of Ratepayer Advocates (ORA) in response to a proposed settlement. Five attending parties filed notices of ex parte communications on the meeting as follows:

(1) California Industrial Group and California Manufacturers Association (“CIG/CMA”), represented by Keith R. McCrea (appearance via telephone) orally communicated support for the settlement, that the settlement was within the scope of the proceeding, and that it did not prejudice issues in the order instituting rulemaking (OIR). Mr. McCrea stated the settlement resolved the core interstate transition cost surcharge (ITCS) issue, and that utility electric generator (UEG) customers should not be exempt from ITCS increases.

(2) Southern California Edison (“Edison”), represented by Gloria M. Ing and others, orally communicated opposition to the May 1998 settlement, and provided

written excerpts from D.97-04-082 to support that opposition. Ms Ing orally cited D.95-07-048 as another basis for opposition. Edison stated the settlement shifts costs to noncore customers not associated with core customers migrating from bundled to unbundled service, that Edison's analysis shows a projected increase of \$51 million a year to California electric consumers and a \$18 million per year windfall to out of state generators selling energy through the Power Exchange, and that the proposed \$5 million annual contribution from noncore to core customers for unbundling the core's capacity is a subsidy.

(3) Southern California Gas Company ("SoCalGas"), represented by Jan Van Lierop and others, conveyed written and oral communications. The five page written ex parte communication, attached to the notice and handed out at the meeting comprised nine paragraphs of "settlement agreement principles," an overview page, and "Noncore ITCS" data page. Mr. Van Lierop orally conveyed that the settlement addresses SoCalGas' core interstate capacity unbundling issues without limiting the Commission's ability to adopt other structural changes in the gas strategy proceeding. SoCalGas further stated the settlement includes a cost advantage for two years for core aggregators and allocates core stranded costs among core and noncore customers without an exemption for electric generation facilities. (4) UtiliCorp Energy Solutions, Inc. ("UES"), represented by John W. Leslie, orally conveyed "strong" opposition to the settlement according to the notice, citing six reasons why the settlement fails to comply with the requirements of D.95-07-048 regarding core interstate unbundling. Among them, Mr. Leslie cited the proposed implementation date is later than that required by D95-07-048, and that the market price mechanism would not encourage SoCalGas to relinquish any of its core capacity, thus denying core transport customers the cost savings attributable to unbundling.
