GLOSSARY

After January 1, 1998, the California Public Utilities Commission is required by statute (SB 960) to categorize each case that comes before it. There are three categories, quasilegislative, adjudicatory and ratesetting. If a case does not require hearings before it is resolved, the case is removed from the SB 960 category requirements. The legend below shows the abbreviation for each of the categories and provides a brief explanation.

- Q **Quasi-legislative** proceedings are proceedings that establish policy or rules (including generic ratemaking policy or rules) affecting a class of regulated entities, including those proceedings in which the Commission investigates rates or practices for an entire regulated industry or class of entities within the industry.
- A **Adjudicatory** proceedings are: (1) enforcement investigations into possible violations of any provision of statutory law or order or rule of the Commission; and (2) complaints against regulated entities, including those complaints that challenge the accuracy of a bill, but excluding those complaints that challenge the reasonableness of rates or charges, past, present, or future.
- RS Ratesetting proceedings are proceedings in which the Commission sets or investigates rates for a specifically named utility (or utilities), or establishes a mechanism that in turn sets the rates for a specifically named utility (or utilities). Ratesetting proceedings include complaints that challenge the reasonableness of rates or charges, past, present, or future.
- N/A Removed from the SB 960 category requirements.

Summary: On August 13, 1998, an official from the City and County of San Francisco mailed an ex parte letter to various PUC officials expressing concern over the Commission's proposal to exercise jurisdiction over disputes between local governments and telecommunications carriers regarding access to public rights of way. The letter states representation—additionally—on behalf of the cities of Los Angeles, San Carlos, and of the San Mateo County Telecommunications Authority (collectively the "Cities"). The page and a half letter, signed by Deputy City Attorney Jayne Lee, was addressed to Commissioner Conlon, and copies provided the other four (4) commissioners, Administrative Law Judge ("ALJ") Pulsifer, and Commissioner Conlon's advisor, Mr. Jose Jimenez. The letter expressed the Cities' opposition to ALJ Pulsifer's draft decision of July 7, 1998, and further that the Cities were "alarmed" over the proposed jurisdictional reach of the Commission. The letter further disagreed with the view that telecommunication carriers could not obtain expedited court procedures to resolve disputes over rights of way, stating required remedies, per Code of Civil Procedure sections 526 and 1085, could be obtained "within a month." The letter also cited Federal Maritime Commission vs Seatrain Lines, (1973) 411 U.S. 726, 745 to illustrate that the Commission may not exercise jurisdiction simply because it has said it could exercise jurisdiction before, a point made to rebut Mr. Jimenez' earlier

statement that similar Commission jurisdiction had been exercised in General Order 159A. In the last paragraph, Ms Lee states the proposal would "interfere" with the Cities' power, and that "local governments should be viewed as partners...(in the effort to support telecommunications competition)...(and)...not as impediments to be pushed out of the way."
