GLOSSARY

After January 1, 1998, the California Public Utilities Commission is required by statute (SB 960) to categorize each case that comes before it. There are three categories, quasilegislative, adjudicatory and ratesetting. If a case does not require hearings before it is resolved, the case is removed from the SB 960 category requirements. The legend below shows the abbreviation for each of the categories and provides a brief explanation.

- Q **Quasi-legislative** proceedings are proceedings that establish policy or rules (including generic ratemaking policy or rules) affecting a class of regulated entities, including those proceedings in which the Commission investigates rates or practices for an entire regulated industry or class of entities within the industry.
- A **Adjudicatory** proceedings are: (1) enforcement investigations into possible violations of any provision of statutory law or order or rule of the Commission; and (2) complaints against regulated entities, including those complaints that challenge the accuracy of a bill, but excluding those complaints that challenge the reasonableness of rates or charges, past, present, or future.
- RS Ratesetting proceedings are proceedings in which the Commission sets or investigates rates for a specifically named utility (or utilities), or establishes a mechanism that in turn sets the rates for a specifically named utility (or utilities). Ratesetting proceedings include complaints that challenge the reasonableness of rates or charges, past, present, or future.
- N/A Removed from the SB 960 category requirements.

Summary: On September 29, 1998, Southern California Edison ("SCE") representatives Bruce Foster and Michael Hoover initiated a meeting at CPUC with Commissioner Neeper and his advisor, David Gamson. In oral ex parte communications, the SCE representatives stated in regard to competition transition charge ("CTC") exemptions under Pub.Util.C. § 369 that standby service is not physically separate from the direct access transaction. While they may be two distinct contracts, SCE said, the direct access transactions the ALJ's proposed decision ("PD") would allow cannot occur without the use of the utility transmission and distribution. They further stated the PD makes a serious error and reaches the wrong conclusion on the exemption by neglecting the word "otherwise" in the analysis of § 369. The SCE representative concluded by saying the PD would result in significant amounts of CTC being shifted from certain, large customers to other customers and this would be unfair.

The fax was page "93" of the draft decision, with Cox's recommended changes inserted near the bottom of page "93," changing the word "commercial" to "multi-tenant" and deleting the phrase "up to the MPOE."
