**Summary:** On February 2, 1998, Jana Corey, Director, Regulatory Relations, Pacific Gas and Electric Company (PG&E) delivered a copy of a letter, signed by Jennifer L. Karas, attorney, PG&E to Cmmrs. Bilas, Conlon, Duque, Knight and Neeper. Copies of the letter were also delivered to ALJ Minkin and Steve Layman of the Energy Division. A copy of letter is attached to this notice. In the letter, PG&E stated that AB 1890 created an effective mechanism that ensures recovery of transition costs from all existing and future consumers in the service territory. It also stated that in Decision 97-12-039, the Commission considering each word in Section 369 and the section as a whole, held that "if the direct transaction requires standby service through the use of transmission or distribution facilities owned by the utility, the exemption described in Section 369 does not apply." Further, the letter stated that, contrary to what others have asserted, the Commission does have jurisdiction over imposing responsibility for CTC recovery and has ample authority to determine how that CTC should be calculated. Finally, PG&E asked that the Commission to vote out the Proposed Decision as written.
