# GLOSSARY

After January 1, 1998, the California Public Utilities Commission is required by statute (SB 960) to categorize each case that comes before it. There are three categories, quasilegislative, adjudicatory and ratesetting. If a case does not require hearings before it is resolved, the case is removed from the SB 960 category requirements. The legend below shows the abbreviation for each of the categories and provides a brief explanation.

- Q **Quasi-legislative** proceedings are proceedings that establish policy or rules (including generic ratemaking policy or rules) affecting a class of regulated entities, including those proceedings in which the Commission investigates rates or practices for an entire regulated industry or class of entities within the industry.
- A **Adjudicatory** proceedings are: (1) enforcement investigations into possible violations of any provision of statutory law or order or rule of the Commission; and (2) complaints against regulated entities, including those complaints that challenge the accuracy of a bill, but excluding those complaints that challenge the reasonableness of rates or charges, past, present, or future.
- RS **Ratesetting** proceedings are proceedings in which the Commission sets or investigates rates for a specifically named utility (or utilities), or establishes a mechanism that in turn sets the rates for a specifically named utility (or utilities). Ratesetting proceedings include complaints that challenge the reasonableness of rates or charges, past, present, or future.
- N/A Removed from the SB 960 category requirements.

# Subscription Notice for Draft Agenda Items

In compliance with Public Utilities Code Section 311.5, parties who wish to subscribe to receive draft agenda items may do so by writing to the Public Utilities Commission; Attention: Poly Arca, Room 1003; 505 Van Ness Avenue; San Francisco, CA 94102; or by calling (415) 703-1798. **Summary:** On March 24, 1998, Eric Eisenman, Director Regulatory Relations for Pacific Gas and Electric Company, (PG&E) met with Julie Halligan, advisor to Cmmr. Bilas in San Francisco. A copy (attached to the notice) of the response of PG&E to emergency motion of Enron Capital and Trade Resources and Enron Services (Enron) filed on February 26, 1998, was used. Eisenman stated that the information requested by Enron in its emergency motion was provided by PG&E in its response to the emergency motion. Eisenman further stated that PG&E's utility electric generation (UEG) function was awarded 232 Mdth/day of capacity on PG&E's Redwood path. Eisenman explained that the UEG bid for Redwood path capacity because it believed that purchasing and utilizing this capacity would lower its fuel cost during the period prior to divestiture of its power plants. Eisenman stated that in the current market environment, purchasing gas at the citygate would be more expensive for the UEG than purchasing gas upstream and transporting it on the Redwood path capacity it had acquired in the open season.
