calling (415) 703-1798. The cost for a one-year subscription to the entire public agenda package (which excludes Executive Session materials) is \$1,000. You may also order a partial agenda package (energy agenda items only or telecommunication agenda items only) at the cost of \$500 per year. The package you receive via mail will include only those agenda items available at the time of the agenda distribution date, which is usually 10 to 12 days prior to the Commission meeting. If agenda items (including revisions) are not ready on the distribution date, they will be made available at no charge in the lobby outside the Commission Auditorium at 9:00 a.m. on the morning of the Commission meeting, but not earlier.

In addition, the Commission will make draft agenda items available for viewing and photocopying (at 20 cents per page) at the Commission's Central Files Office (Room 2002), 505 Van Ness Avenue, San Francisco, and in the Los Angeles, San Diego, and the following field offices: El Centro, Eureka, Sacramento and San Bernardino. Since the agenda package will be mailed to these locations, it will be available at these locations a day or two after the distribution date. These locations will not receive agenda items that are not ready on the distribution date.

If an agenda item is held over to a subsequent Commission meeting, that agenda item and any revisions to that agenda item that were available on the morning of the initial Commission meeting (as well as any further available revisions) will be mailed in the Escutia package for the subsequent Commission meeting; the item and its revisions will also be available for viewing and photocopying in the Commission's Central Files Office and field offices as set forth above.

NXX CODE LOTTERY WORKSHOP

The Telecommunications Division of the California Public Utilities Commission will be holding a second technical workshop on fine-tuning the NXX Code Lottery held each month at the CPUC. Decision 98-08-037 found there is a need for a fresh review of lottery procedures. In this second workshop, the lottery process will be reviewed to determine if there are ways to make the distribution of NXX codes among carriers more equitable, and more conducive to the development of competition. Specifically, the topic of increasing the percentage of initial codes assigned from the lottery from the current 60% to a higher amount will be explored. Participants should come prepared to address potential reform measures for the lottery, identify potential shortcomings and suggest ways to revise the

lottery process to promote a more competitive market including potential revisions in the allocation between initial and growth codes.

On December 7, 1998, Cynthia Marshall - Executive Director, Regulatory, Pacific Bell (PacBell), held two separate meetings with members of the Telecommunications Division in San Francisco. Also present was Peggy Garber, General Attorney - Legal, for PacBell. Telecommunications Division staff present at the first meeting included: Phil Enis, Michael Amato, Karen Jones, and Jonathan Lakritz; at the second - Jack Leutza and Michael Amato. Mary Vanderpan - Vice President - Regulatory, PacBell, was present at the second meeting. Written materials (attached to the notice) were used. At the first meeting, PacBell representatives expressed their overall support for the proposed decision (PD). PacBell's representatives also discussed changes to the language regarding Tru Call Testing and distributed a handout (attached to the notice) with the proposed changes. At the second meeting, PacBell's representatives Marshall, Garber, and Vanderpan discussed the path forward for the proceeding. Summary: On December 10, 1998, Jonathan Bromson, attorney for the Office of Ratepayer Advocates (ORA), met with Cmmr. Neeper in San Francisco. Also present were: David Gamson, advisor to Cmmr. Neeper, and Elena Schmid, Director of ORA. ORA stated its support for the draft decision of ALJ Econome, its qualified support for the alternate of Cmmr. Conlon, and its strong opposition to the alternate of Cmmr. Bilas and Neeper. ORA noted that the July 5, 1995 assigned commissioner's ruling (ACR) must be applicable to the settlements entered into prior to that date, because the Commission in D95-03-019 announced it was suspending consideration of advice letter filings of such settlements pending further order of the Commission. ORA explained that the ACR required that each utility only submit one package of settlements to ensure consistent treatment of all settlements. ORA further noted that even if the Commission deems it proper to evaluate the settlements without consideration to the ACR's guidelines, the settlements were unreasonable because they explicitly allowed for ongoing litigation by Southern California Edison Company (Edison) at Federal Energy Regulatory Commission (FERC) challenging the biennial resource plan update (BRPU). ORA pointed out that the settlements did not avoid litigation, but explicitly allowed the Edison litigation that successfully resulted in the FERC advisory order in February, 1995 which caused the Commission in turn to suspend the solicitation. ORA stated that the initial settlements failed to "settle" all issues traceable to the BRPU solicitation, and it was only this Commission through the ACR's encouragement for settlement that managed to avoid litigation.
