NXX CODE LOTTERY WORKSHOP

The Telecommunications Division of the California Public Utilities Commission will be holding a second technical workshop on fine-tuning the NXX Code Lottery held each month at the CPUC. Decision 98-08-037 found there is a need for a fresh review of lottery procedures. Summary: On December 10, 1998, Jonathan Bromson, attorney for the Office of Ratepayer Advocates (ORA), met with Cmmr. Neeper in San Francisco. Also present were: David Gamson, advisor to Cmmr. Neeper, and Elena Schmid, Director of ORA. ORA stated its support for the draft decision of ALJ Econome, its qualified support for the alternate of Cmmr. Conlon, and its strong opposition to the alternate of Cmmr. Bilas and Neeper. ORA noted that the July 5, 1995 assigned commissioner's ruling (ACR) must be applicable to the settlements entered into prior to that date, because the Commission in D95-03-019 announced it was suspending consideration of advice letter filings of such settlements pending further order of the Commission. ORA explained that the ACR required that each utility only submit one package of settlements to ensure consistent treatment of all settlements. ORA further noted that even if the Commission deems it proper to evaluate the settlements without consideration to the ACR's guidelines, the settlements were unreasonable because they explicitly allowed for ongoing litigation by Southern California Edison Company (Edison) at Federal Energy Regulatory Commission (FERC) challenging the biennial resource plan update (BRPU). ORA pointed out that the settlements did not avoid litigation, but explicitly allowed the Edison litigation that successfully resulted in the FERC advisory order in February, 1995 which caused the Commission in turn to suspend the solicitation. ORA stated that the initial settlements failed to "settle" all issues traceable to the BRPU solicitation, and it was only this Commission through the ACR's encouragement for settlement that managed to avoid litigation.
