Summary: On January 28, 1999, Bruce Foster, Southern California Edison Company's (Edison) Vice President, met with Michelle Cooke, advisor to Cmmr. Duque, in San Francisco. Also present was Mike Hoover, Director of Edison's San Francisco's office. Written materials (attached to the notice) were used. Foster described the operation of the Commission's performance-based ratemaking procedure authorized in D96-09-092. Foster stated that Edison's rates are fixed through 2001, except for adjustments for inflation and assumed levels of productivity under a formula known as "CPI minus X". Foster explained that the cost of capital trigger mechanism automatically adjusts Edison's return on equity for changes in economic conditions based on the 12-month average of Aa utility bond rates. Foster stated that Edison's performance-based ratemaking (PBR) rates and the trigger mechanism were implemented by Commission resolution which was effective January 1, 1997. Referring to Edison's petition to modify D97-08-056 in light of the recent adoption of the cost of capital trigger mechanism, Foster stated that, although the Commission denied Edison's petition in D97-11-073, it did state that Edison could make its point in this proceeding regarding the operation of the cost of capital trigger mechanism. Foster explained that the limited purpose for Edison's participation in this proceeding was to review generic issues related to unbundling cost of capital. Foster noted that the Office of Ratepayer Advocates, The Utility Consumer Action Network and Dr. James Weil propose to adjust Edison's return not only for an alleged unbundling discount, but they also propose substantial reductions in Edison's return based on changes in economic conditions which have occurred since the trigger mechanism was implemented. Foster argued that their proposal would violate the automatic adjustment feature of the Commission's trigger mechanism. Foster noted that with respect to the alleged unbundling discount, the record shows the UDC is not less risky than the former integrated utility. Foster also described Edison's unique position in this case and discussed he history of the Commission's cost of capital decision for Edison and Southern California Gas Company.
