A draft resolution (M-4793) of the Executive Division approving disclosure of information concerning utility readiness with respect to the Year 2000 (Y2K) computer problem, including utility responses to resolution M-4792, dated November 19, 1998, will be on the April 1, 1999 Commission meeting agenda. The Commission may vote on this resolution at that time, or it may postpone a vote until later. When the Commission votes on M-4793, it may adopt all or part of it as written, amend or modify it, or set it aside and prepare a different resolution.

The draft resolution was circulated on March 2, 1999 to the Resolution M-4792 Service List, and to other entities, such as certain passenger stage corporations and vessel common carriers, who have been asked to provide information concerning their Y2K readiness.

confidential. An entity should not seek confidential treatment of any information which has been made publicly available through Y2K readiness reports filed by that entity with other agencies or through reports posted on the entity's web site. Any request for confidentiality must be filed prior to the close of the comment period for this resolution.
