Summary: On March 23, 1999 Enron Corp. ("Enron") initiated an ex parte meeting at CPUC with Commissioner Neeper and advisor David Gamson. Enron's Mono Petrochko and Jeanne Bennett stated that the proposed decisions issued by the administrative law judge ("ALJ") and Commission President Bilas reflected Enron's concerns through a careful deliberation of the costs incurred by the three (3) utility distribution companies ("UDC's) to implement electric restructuring, and those which went further to position the UDC's in the competitive marketplace. This was notwithstanding that Enron's position

was not expressly adopted in the decisions. Ms Petrochko further stated the ALJ's proposed decision "got it right" in its conclusion that the costs of the latter should be recovered from the market and not through monopoly distribution rates.

Summary: On March 24, 1999, GTE California, Inc. ("GTE"), initiated ex parte communications with PUC officials at Commission headquarters. On that date GTE conducted a meeting with Lester Wong and Tim Sullivan, advisors to Commission President Bilas and Commissioner Duque respectively. This was followed up on March 29, 1999 with a GTE letter addressed to all of the commissioners and other PUC staff. Attending the 3/24/99 meeting for GTE were Jenny Wong, Gerald Harris, Rodney Langley, Doug Wellemeyer, and Lupita Reyes. GTE briefed the PUC officials on its analysis to date in comparing the adopted OSS/NRC costs (per D.98-12-079) to GTE's proposed OSS/NRC costs. GTE stated the analysis indicates that for the link and port, the Commission adopted significantly higher costs than GTE proposed in its costs studies. GTE further indicated the adopted cost structure for GTE is based on Pacific Bell's ("PacBell") business processes and systems, and thus GTE's NRC pricing proposal is not supportable by the form of the adopted non-recurring costs results produced by PacBell's studies. GTE further noted D.98-12-079 was incomplete regarding its treatment of Resale NRC's for GTE, and urged the Commission to stay the decision for GTE and re-evaluate the usefulness of GTE's own NRC cost studies with appropriate adjustments. The 3/29/99 letter to the commissioners signed by Ms Wong reiterated many points made in the earlier meeting. The first sentence states "GTE is deeply concerned with the impact of D.98-12-079 in which the Commission adopted Pacific Bell's Non-Recurring Costs (NRC) Study for unbundled network elements (UNEs) and imposed on GTE California." Ms Wong then stated GTE believes the Commission's action in the decision violated the 1996 Telecommunications Act and that "as importantly, GTE is concerned with the implications of this decision on the various pricing and cost issues currently before the Commission." In concluding the letter, Ms Wong "urges that a revisit of D.98-12-079 is necessary in order to ensure that the established regulatory goals of fairness and economic efficiency, as related to pricing, are achieved." Attached to the letter was a seventeen (17) page package detailing GTE's concerns in these areas.

Summary: On March 25, 1999 representatives from OpTel (California) Telecom, Inc. ("OpTel") initiated consecutive ex parte meetings at CPUC with (1) Lester Wong and Timothy Sullivan, advisors to Commission President Bilas and Commissioner Duque, respectively, and (2) Commissioner Neeper and advisor Fassil T. Fenikile. OpTel stated that Pacific Bell ("PacBell") refuses to cooperate with property owners to reconfigure wiring installations in multiple dwelling unit properties. As a result, OpTel said, they have been unable to furnish service at a number of such properties. Referring back to 1997 negotiations between Optel and PacBell, Optel said PacBell has recently indicated it would not follow through on those earlier negotiations until such time as the Commission makes a final determination on the issues related to those wiring reconfigurations. Optel said PacBell's refusal to negotiate is unjustified and anti-competitive, contrasting that with Optel's successful negotiations with PacBell's counterpart in Texas, Southwestern Bell. Optel urged enforcement actions now against PacBell on existing tariff obligations to reconfigure wiring. Optel concluded by stating that other issues then remaining should be addressed expeditiously as well. To illustrate the problem, Optel provided the PUC officials a sample map of a multi-unit property.
