In compliance with Public Utilities Code Section 311.5, parties who wish to subscribe to receive draft agenda items may do so by writing to the Public Utilities Commission; Attention: Poly Arca, Room 1003, 505 Van Ness Avenue, San Francisco, CA 94102, or by calling (415) 703-1798. The cost for a one-year subscription to the entire public agenda package (which excludes Executive Session materials) is \$1,000. You may also order a partial agenda package (energy agenda items only or telecommunication agenda items only) at the cost of \$500 per year. The package you receive via mail will include only those agenda items available at the time of the agenda distribution date, which is usually 10 to 12 days prior to the Commission meeting. If agenda items (including revisions) are not ready on the distribution date, they will be made available at no charge in the lobby outside the Commission Auditorium at 9:00 a.m. on the morning of the Commission meeting, but not earlier.

**Summary:** On May 4, 1999 Pacific Gas & Electric Co. ("PG&E") told Commissioner Neepner the utility appreciated the proposed decision's ("PD") grant of extension of time for implementing the weekly average PX pricing. However the utility added that the PD's criticism of PG&E's billing system management for the last twelve (12) years was unwarranted and unsupported. In the meeting at CPUC initiated by PG&E's Jana Corey and



Andrew Niven, they stated the complexity of PG&E's billing system was not fundamental to the grant of an extension of time, and that the issue is being considered in another proceeding. Mr. Niven stated PG&E might have prepared different testimony for the 11/13/98 hearing if the utility had known that a reasonableness review of the billing system was going to be addressed. He noted the original purpose of the hearing was only to address the need of an extension. Urging an extension of time for implementing the weekly average PX pricing methodology, Mr. Niven concluded by requesting findings of fact "1," "2," and "4, conclusion of law "2," and commentary regarding reasonableness of PG&E's management of its billing system all be removed from the PD.
