The cost for a one-year subscription to the entire public agenda package (which excludes Executive Session materials) is \$1,000. You may also order a partial agenda package (energy agenda items only or telecommunication agenda items only) at the cost of \$500 per year. The package you receive via mail will include only those agenda items available at the time of the agenda distribution date, which is usually 10 to 12 days prior to the Commission meeting. If agenda items (including revisions) are not ready on the distribution date, they will be made available at no charge in the lobby outside the Commission Auditorium at 9:00 a.m. on the morning of the Commission meeting, but not earlier.

("Enron") told Commission advisor David Gamson in a meeting held at CPUC that Enron supported the revised proposed decisions ("PD") of ALJ Minkin regarding Southern California Edison Co.'s application and Pacific Gas & Electric Co. and San Diego Gas & Electric Co.'s settlement in the "Section 376" proceedings. Enron representative Mono Petrochko told Mr. Gamson the decisions equally considered the concerns of both the UDC's and the ESP community. While the proposed decisions did not adopt the functionalization proposal of Enron, Ms Petrochko stated, they did adopt certain underlying concepts in their proposal. A second Enron representative attending the meeting was attorney Jeanne Bennett, of Goodin, MacBride, Squeri, Ritchie &

Day, LLP. All communications were oral.

Summary: On May 4, 1999 Enron Corp. ("Enron") told David Gamson the proposed decision ("PD") issued by Administrative Law Judge Malcolm provided no relief to the electric service provider community. Mr. Gamson is an advisor to Commissioner Neeper. Enron said the PD erred in adopting an avoided cost approach for determining which costs should be reflected in the PX credit. The issue, Enron said, is not which costs are avoided, but what costs are incurred by the UDC to provide procurement service to bundled service customers. The latter, Enron said, are costs which must be recovered through Schedule PX (and thus reflected in the PX credit). The ex parte communication occurred during a meeting at CPUC initiated by Enron. Representing Enron were Sue Mara, Mona Petraochko. Peter Bray of the Western Power Trading Forum ("WPTF") accompanied the Enron contingent. No written materials were provided during the meeting.
