The package you receive via mail will include only those agenda items available at the time of the agenda distribution date, which is usually 10 to 12 days prior to the Commission meeting. **Summary:** On May 17, 1999, Pacific Gas & Electric Co. ("PG&E") told Commissioner Neeper the issue on the Letterman boiler project had arisen quickly in the proceeding and that was the reason the National Park Service ("NPS") and the Presidio Trust ("PT") were not able to react in time to rebut the notion that the project would have proceeded despite the PG&E contract. The PG&E official conveying that to the commissioner was attorney Robert McLennan. Mr. McLennan said the proposed decision's conclusion to the contrary was the result of that gap in evidence, and that PG&E is likely to make a motion under Rule 84 to set aside the submission and reopen the proceeding. A revised record, Mr. McLennan said, will show the Letterman project would not have occurred without PG&E's intervention. This oral ex parte communication occurred in a meeting at CPUC initiated by the utility. Others present included Paul Storz and Chris Chouteau of PG&E, Paul Batlan of NPS, and Maric Munn, energy manager of the PT.
