The cost for a one-year subscription to the entire public agenda package (which excludes Executive Session materials) is \$1,000. You may also order a partial agenda package (energy agenda items only or telecommunication agenda items only) at the cost of \$500 per year. The package you receive via mail will include only those agenda items available at the time of the agenda distribution date, which is usually 10 to 12 days prior to the Commission meeting. If agenda items (including revisions) are not ready on the distribution date, they will be made available at no charge in the lobby outside the Commission Auditorium at 9:00 a.m. on the morning of the Commission meeting, but not earlier.

In addition, the Commission will make draft agenda items available for viewing and photocopying (at 20 cents per page) at the Commission's Central Files Office (Room 2002), 505 Van Ness Avenue, San Francisco, and in the Los Angeles, San Diego, and the following field offices: El Centro, Eureka, Sacramento and San Bernardino. Since the agenda package will be mailed to these locations, it will be available at these locations a day or two after the distribution date. These locations will not receive agenda items that are not ready on the distribution date.

Draft Resolution Approving Disclosure Of Investigative Report of the Utilities Safety Branch (USB) and Correspondence between USB and Southern California Edison Company Available For Public Review And Comment.

A draft resolution (L-279) of the Legal Division approving disclosure of information concerning incident 19980527-01, dated May 24, 1999, will be on the June 24, 1999 Commission meeting agenda. The Commission may vote on this resolution at that time, or it may postpone a vote until later. When the Commission votes on L-279, it may adopt all or part of it as written, amend or modify it, or set it aside and prepare a different resolution.

The draft resolution was circulated on May 24, 1999 to the requesting party, Douglas M. Booth and to Southern California Edison Company.

Interested parties may request that USB's investigative report and correspondence with Southern California Edison Company be treated as confidential. Interested parties seeking confidential treatment should recognize the strong public interest in disclosure of information concerning incidents involving public utilities, and should seek confidential treatment only if they can demonstrate to the Commission's satisfaction both that the portions they wish kept confidential fall within a specific exemption in the California Public Records Act (Government Code Section 6250 et seq.) and that the public interest in nondisclosure clearly outweighs the public interest in disclosure. Any request for confidentiality must be filed prior to the close of the comment period for this resolution.

5/25/99 A98-11-024 Pacific Bell, for arbitration of an interconnection agreement with Pac-West Telecomm, Inc., pursuant to section 256(b) of the Telecommunications Act of 1996.

Summary: On May 21, 1999 Kathryn L. Thomas telephoned Timothy Sullivan and told him that CLEC's ("competitive local exchange carriers") would suffer devastating effects if the alternate proposed decision ("APD") is adopted. Ms Thomas represents Advanced Telcom Group, Inc., a member of the California Assoc. of Competitive Telecommunications Companies ("CalTel"). Mr. Sullivan is an advisor to Commissioner Duque. Ms Thomas urged that current Commission precedent on the issue of reciprocal compensation be maintained. Ms Thomas said the APD would thwart expansion of ISP traffic in California because under it the CLEC's could not get compensated. She said the APD would adversely impact other carriers' agreements and that it is contrary to several other states' decisions on the issue of reciprocal compensation.

Summary: On May 24, 1999 a member of the California Assoc. of Competitive Telecommunications Companies ("CalTel") wrote a letter to all of the commissioners indicating that Commission adoption of the alternate proposed decision ("APD") "which would reverse the Commission's current position on the obligation to pay reciprocal

compensation on ISP bound traffic, is not required by the FCC's Declaratory Ruling, is inconsistent with that ruling, and may well violate both the law and the Constitution." The four (4) letter was written by Michael J. Mahoney, President and CEO of "RCN Telecom Services of California." Mr. Mahoney concludes the letter with the statement "We urge the Commission to adopt the PD...(proposed decision)...which is fully consistent with the law as well as the FCC's Declaratory Ruling."
