The package you receive via mail will include only those agenda items available at the time of the agenda distribution date, which is usually 10 to 12 days prior to the Commission meeting. Draft Resolution Approving Disclosure Of Investigative Report of the Utilities Safety Branch (USB) and Correspondence between USB and Southern California Edison Company Available For Public Review And Comment.

A draft resolution (L-279) of the Legal Division approving disclosure of information concerning incident 19980527-01, dated May 24, 1999, will be on the June 24, 1999 Commission meeting agenda. The Commission may vote on this resolution at that time, or it may postpone a vote until later. When the Commission votes on L-279, it may adopt all or part of it as written, amend or modify it, or set it aside and prepare a different resolution.

The draft resolution was circulated on May 24, 1999 to the requesting party, Douglas M. Booth and to Southern California Edison Company.

Interested parties may request that USB's investigative report and correspondence with Southern California Edison Company be treated as confidential. Interested parties seeking confidential treatment should recognize the strong public interest in disclosure of information concerning incidents involving public utilities, and should seek confidential treatment only if they can demonstrate to the Commission's satisfaction both that the portions they wish kept confidential fall within a specific exemption in the California Public Records Act (Government Code Section 6250 et seq.) and that the public interest in nondisclosure clearly outweighs the public interest in disclosure. Any request for confidentiality must be filed prior to the close of the comment period for this resolution.
