The cost for a one-year subscription to the entire public agenda package (which excludes Executive Session materials) is \$1,000. You may also order a partial agenda package (energy agenda items only or telecommunication agenda items only) at the cost of \$500 per year. The package you receive via mail will include only those agenda items available at the time of the agenda distribution date, which is usually 10 to 12 days prior to the Commission meeting. If agenda items (including revisions) are not ready on the distribution date, they will be made available at no charge in the lobby outside the Commission Auditorium at 9:00 a.m. on the morning of the Commission meeting, but not earlier.

In addition, the Commission will make draft agenda items available for viewing and photocopying (at 20 cents per page) at the Commission's Central Files Office (Room 2002), 505 Van Ness Avenue, San Francisco, and in the Los Angeles, San Diego, and the following field offices: El Centro, Eureka, Sacramento and San Bernardino. These locations will not receive agenda items that are not ready on the distribution date.

Draft Resolution (M-4794) Regarding the Level of Public Utilities Commission
Transportation Reimbursement Account Fees to be Imposed for Fiscal year 1999-2000

Pursuant to Public Utilities Code Section 421 (added 1983, Chapter 323), the Commission is required to annually determine a fee to be paid by every passenger stage corporation, charter party carrier of passengers, pipeline corporation, for-hire vessel operator, common carrier vessel operator, railroad corporation, and commercial air operators and every other common carrier and related business subject to the jurisdiction of the Commission, except as provided in Section 431 (other public utilities). The annual fee shall be established to produce a total amount equal to the amount established in the authorized Commission budget to support the Commission's regulatory activities for the class from which the fee is collected, including adjustments for increases in employee compensation, other increases appropriated by the Legislature, and an appropriate reserve, less the amount to be paid from special accounts or funds pursuant to Public Utilities Code Section 403, reimbursements, federal funds, other revenues, and unencumbered funds from the preceding year.

The staff's proposed resolution will continue the fees at the same levels fixed for the current (1998-99) fiscal year for passenger vehicle operators, vessel operators, commercial air operators and pipeline corporations.

Draft Resolution M-4795 Regarding the Level of Transportation Rate Fund Fee to be Imposed for Fiscal Year 1999-2000

Pursuant to Section 5003.1 of the Public Utilities Code (amended 1996, Chapter 1042), every household goods carrier owning or operating motor vehicles in the transportation of property for hire upon the public highways under the jurisdiction of the Commission shall...pay to the Commission a fee equal to one third of one percent of the amount of such gross operating revenue. Section 5003.2 of the PU Code further provides that the Commission may raise the fee imposed by Section 5003.1 up to a maximum of one-half of 1 percent of gross operating revenue if the Commission decides this increase is necessary to maintain adequate financing for the Transportation Rate Fund.

The proposed resolution will continue the fees at the same levels fixed for the current (1998-99) fiscal year for household goods carriers which is one-half of one percent (.005) of gross operating revenue for all household goods carriers owning or operating motor vehicles in the transportation of property for hire upon the public highways under the jurisdiction of the Commission.

Draft Resolution (M-4796) Regarding the Level of Public Utilities Commission utilities Reimbursement Account Fees to be Imposed for Fiscal year 1999-2000

Pursuant to Public Utilities Code Section 431 (added 1983, Chapter 323), the Commission is required to annually determine a fee to be paid by every electrical, gas, telephone, telegraph, water, sewer system, and heat corporation and every other public utility providing service directly to customers or subscribers and subject to the jurisdiction of the Commission, except as provided in Section 421 (common carriers and related businesses). The annual fee shall be established to produce a total amount equal to that amount established in the authorized Commission budget for the same year (including adjustments for increases in employee compensation, other increases appropriated by the Legislature, and an appropriate reserve) to regulate public utilities less the amount to be paid from special accounts or funds, reimbursements, federal funds, and any other revenues, and the amount of unencumbered funds from the preceding year.

The proposed resolution will continue the fees at the same levels fixed for the current (1998-99) fiscal year for electric, gas and heat, telephone and telegraph, and water and sewer system corporations as show below:

Summary: On June 7, 1999, Pacific Gas & Electric Co. ("PG&E") representatives conducted three (3) consecutive ex parte meetings at CPUC with (1) Michelle Cooke, advisor to Commissioner Duque, (2) David Gamson, advisor to Commissioner Nepper, and (3) Julie Halligan, advisor to Commission President Bilas. PG&E principals involved were Jana Corey and Andrew Niven. The content of each communication was the same, except

that certain written testimony was provided to Commissioner Duque's advisor in the first meeting. In the second and third meetings, only oral communications were conveyed. Ms Corey stated the second sentence in Finding of Fact "1" suggesting PG&E wasted \$80 million has been heavily rebutted in PG&E's 1999 GRC. Mr. Niven stated PG&E initiated changes to its billing system in the 1980's, and he also indicated that the decision's reference to PG&E's "mislead(ing)...the Commission" was not correct. The PG&E representatives concluded by stating while Fact "3" was technically correct, the implication of improper behavior was not correct. Other details were cited in support of PG&E's position. The written materials provided to Ms Cooke were pages "I-9" through "I-12" of PG&E's prepared testimony dated 11/10/98, titled "Petition to Modify Decision Nos. 97-08-056 and 98-03-050 concerning the calculation of PX prices." Summary: On June 8, 1999 a representative of the Office of Ratepayer Advocates ("ORA") initiated contact with Commission President Bilas' staff and requested that he support item H-5 on the June 10 agenda and further stating that PG&E's M&V plan carried flawed assumptions on the Letterman Hospital site. Summary: On June 8, 1999, MCI WorldCom, Inc. ("MWC") representatives initiated consecutive ex parte meetings at CPUC with (1) Commissioner Neeper, and (2) Commission President Bilas. MWC principals attending were James L. Lewis and Richard B. Severy. Communications in each meeting were substantially identical. A twelve (12) page written handout "Bringing Residential Competition to California" was provided to each commissioner. MCIWorldCom was committed to entering the local market, the representatives stated, but additional changes in the UNE prices in the ALJ's proposed decision ("PD") are required before it would be economically viable for new entrants to serve residential customers. Mr. Severy stated the UNE prices that CLEC's would pay under the PD exceed the incumbent's current retail rates, thus preventing CLEC's the ability to compete. The PD fails to comply with the Telecom Act, Mr. Severy stated, because it fails to make reasonable adjustments. Thus the resulting prices are not cost based and are discriminatory, he said. The handout lists several aspects of MCI WorldCom's efforts in New York and other issues, including that "Yellow Pages Contribution Should Be Nondiscriminatory" and "PD's Reasons for Not Fixing USF Problem Can Be Addressed." One page states "Costs Exceed Revenues" and contains two columns of figures to illustrate the point.
