In compliance with Public Utilities Code Section 311.5, parties who wish to subscribe to receive draft agenda items may do so by writing to the Public Utilities Commission; Attention: Poly Arca, Room 1003, 505 Van Ness Avenue, San Francisco, CA 94102, or by calling (415) 703-1798. The cost for a one-year subscription to the entire public agenda package (which excludes Executive Session materials) is \$1,000. You may also order a partial agenda package (energy agenda items only or telecommunication agenda items only) at the cost of \$500 per year. The package you receive via mail will include only those agenda items available at the time of the agenda distribution date, which is usually 10

to 12 days prior to the Commission meeting. If agenda items (including revisions) are not ready on the distribution date, they will be made available at no charge in the lobby outside the Commission Auditorium at 9:00 a.m. on the morning of the Commission meeting, but not earlier.

In addition, the Commission will make draft agenda items available for viewing and photocopying (at 20 cents per page) at the Commission's Central Files Office (Room 2002), 505 Van Ness Avenue, San Francisco, and in the Los Angeles, San Diego, and the following field offices: El Centro, Eureka, Sacramento and San Bernardino. Since the agenda package will be mailed to these locations, it will be available at these locations a day or two after the distribution date. These locations will not receive agenda items that are not ready on the distribution date.

Stakeholder Roundtable on CPUC Innovations

The *Stakeholder Roundtable* is a key element of our ongoing effort to assure that the way the California Public Utilities Commission (CPUC) conducts business is fully aligned with evolving publicly-valued needs and expectations.

Federal and state utility deregulation, technological change, as well as other current issues with widespread impact including area code proliferation, local and long distance telephone competition, competition in electricity services, and the need for consumer education and protection in competitive industries. All of these make it imperative for the CPUC to continue to strive to address stakeholder and public needs in innovative and efficient ways.

The goal of the *Stakeholder Roundtable* is to hear your suggestions for specific, feasible, needed innovations at the CPUC with respect to, for instance, changes in processes, rules, ways of conducting business, and ways we interact and communicate with the public and others. We also seek ideas from our employees on how we can make the Commission a more fulfilling place to work.

Recently, the Commission issued its *Draft 1999 – 2000 CPUC Business Plan* for stakeholder review and comment (available www.cpuc.ca.gov). Within it are ongoing process reform efforts, planned innovations in expanded electronic access to the CPUC, and additional planned streamlined procedures to benefit stakeholders and the public directly. The *Draft Business Plan* incorporates a set of eight good government initiatives I proposed this spring and the Directors' responses to an innovation survey conducted by the Governor's Office of Innovation in Government. These documents are available on the Commission website in association with this notice.

The *Stakeholder Roundtable* is intended to go a step further by enabling us to hear firsthand from electric, telephone, and gas utilities and providers, rail, water, transportation, and other regulated entities. We also seek input from the public, consumer groups, industry labor representatives, legislators, the Administration, other government agencies, employee advocacy groups and employee union representatives about innovations or improvements you think we should make to better serve public and stakeholder interests, and how we should begin to implement them expeditiously. Submission Instructions for Stakeholder Roundtable:

As a starting point, the Roundtable will consider:

Where are we now?
Where should we be?
How do we get there?

In asking, "Where should we be?" the Commissioners seek constructive ideas on making the agency effective, efficient, and future-oriented. Areas for discussion might include, for example:

New or evolving regulatory models for the Commission's regulatory, oversight, education, consumer protection, and enforcement roles;
Communication, both to and from the Commission, and access to Commission information, focusing on ease of use, availability of information or employees, and the timeliness and value of available information;
Electronic interfacing between the Commission and stakeholders, and e-business processes including the transferring information to and sharing of databases;
The development of expert systems or automated processes for repetitive business processes; and
Feedback mechanisms to continuously inform the Commission of a need to re-align its processes to address changing circumstances or enhanced technology.

The Commission requests that all potential participants provide on or before September 20, 1999, a one-page summary of their innovation suggestions so that they can be compiled into general topic areas for panel selection and circulated electronically to participants prior to the *Roundtable* to facilitate a valuable dialogue. An agenda, including a designation of topic panels, for the *Roundtable* will be returned to all respondents on October 5, 1999. Non-panel participants may address the *Roundtable* during a general comment period.

Following the initial *Roundtable*, staff teams will review the replies, conduct any needed public workshops to discuss comments on stakeholder suggestions, and prepare an implementation plan for Commission consideration.

Introduction: President Bilas, Commissioner Hyatt, and Steve Nissen of the Governor's Office of Innovation in Government (Moderator)

First Panel: The Role and Transformation of Government

(1:10 – 2:20 p.m. Break 2:20 – 2:30 p.m.)

The revolution in deregulating traditional utility industries sought to advance and protect the public interest through open access and competitive markets to gain efficiencies, economies and innovations unavailable or unlikely through the traditional regulatory model.

The PUC and its sister agencies are challenged to continue into uncharted territory beyond market startup to continuously refine their roles and the means to provide innovative services to all stakeholders. In reaching for creative, outside the box service scenarios, the Commission should consider:

What is the role of government? How has it changed with deregulation? How will it change over the next decade?

What is the nature of innovation? How is a climate to foster it facilitated? What use is it in government?

How can innovation, competition and regulation be mixed? How can a regulatory organization reinvent itself to eliminate historical bureaucracy and move to 21st century strategies?

What's our bigger picture? What impacts do our decisions have globally?

What do our stakeholders want and need?

Second Panel: e-PUC – Upgraded Web site and Electronic Business Processes
(2:30 – 3:15 p.m.)

The PUC was in the vanguard of California agencies establishing the first generation Internet web sites to provide information to the public and our stakeholders about activities of the agency. As the PUC passes through the Y2K era, we perceive a need to develop a web site which not only provides users access to our decisions and public records (pursuant

to SB 779) but also creates a dynamic gateway into the PUC's business processes and knowledge base.

What dynamic information about Commission activities is useful for regular users of the PUC web site? What static "library" of decisions and public records do web site users need?

Assuming an electronic filing and service capability for PUC proceeding participants is needed, how should issues of security, confidentiality, and certification of service be addressed?

What types of information would add value to consumer web site users? Should consumer education materials be interactive and/or multi-lingual? Should the PUC objectively compile and present comparison-shopping information on services subject to its oversight?

Are there potential processing benefits from the secured sharing of databases between the PUC and service providers, including the PUC's processing of customer complaints?

Third Panel: Streamlining Processes and Alternative Dispute Resolution

Historically, many of the PUC's regulatory processes were patterned after a judicial model to provide impartiality and transparent fact-finding and decision-making processes. Due to legislatively perceived problems, additional rules and processes were added to the judicial model, making it at times inappropriately burdensome and lengthy. For participants in the fast-paced competitive marketplaces being processed in the regulatory regime, too much time results in opportunities lost.

What alternatives to the traditional judicial model are available for the regulatory and policy-making processes of the PUC?

How can the use of alternative dispute resolution processes be maximized?

What safeguards can be built into less legalistic and more collaborative processes to assure open, fair and impartial policy-making and decision-making?

How can the advice letter process be expedited while still affording complete analysis and opportunity to be heard?

The CPUC invites all interested agencies and the public to comment on the Draft Environmental Impact Report (EIR) for the Lodi Gas Storage Application. The Draft EIR can be viewed at the Sacramento, Lodi, Walnut Grove, Isleton, and Stockton Public Libraries. The deadline for submitting written comments on the Draft EIR is November 11, 1999.

The CPUC released for public review and comment a Draft EIR for the project. Lodi Gas Storage, LLC, applied to the CPUC for approval to construct and operate a natural gas storage field near Lodi, California, and an approximately 33-mile pipeline in California's San Joaquin and Sacramento Counties. The Draft EIR contains environmental analyses and recommended mitigation measures for impacts that may occur if the project is approved. The CPUC's review analyzed topics such as agricultural, air quality, biological, and water resource impacts for the proposed pipeline and alternative routes. Two alternative routes follow public rights-of-way and an existing PG&E pipeline, and another alternative is a composite of all of the pipeline routes.

If approved, the CPUC will grant Lodi Gas Storage, LLC, a Certificate of Public Convenience and Necessity. The proposed project includes a separation facility that removes the water from gas, 11 natural gas withdrawal/injection wells, three monitoring wells, a compressor and dehydration station, and a 33-mile pipeline. The natural gas pipeline would connect to PG&E's pipeline system. Lodi Gas Storage plans to use the storage and pipeline to respond to market demands and fluctuations in the price of natural gas.

Summary: On September 29, 1999, An all party meeting was held in the Commission's office in San Francisco. In attendance were Cmmr. Wood and his advisor, Kevin Coughlan; Jana Corey, Director, Regulatory Relations, Dan Richard, Senior Vice President, Public Affairs and Christopher Warner, Chief Counsel, for Pacific Gas and Electric Company (PG&E); Lynn Van Wagenen, representing San Diego Gas & Electric Company (SDG&E); Scott Couchois for the Office of Ratepayer Advocates; Edward O'Neill for the California Power Exchange; Jeanne Bennett for Alliance for Retail Markets; James Weil for Aglet; Reed Schmidt for California Streetlight Association; Marc Joseph for Coalition of Utility Employees; Jim Lehrer for Southern California Edison; Keith Melville for Sempra representing SDG&E; Kerry Hattevik for the Commission Energy Division; and Derk Pippin for California Energy Markets. Written materials was provided and attached to the notice. Richard stated that the Diablo Canyon Incremental Cost Incentive Pricing (ICIP) D.97-05-088 expressly adopts a price schedule for each year beginning in 1997 and ending in 2001. Further, Richard stated that ICIP recovers ongoing costs, while Diablo Canyon transition cost recovery is for sunk costs. Richard stated Commission intended to provide nuclear plants with the opportunity for a certain transition to competition to minimize any resulting disruption to the power markets that the transition might cause. Finally, Richard stated that the proposed decision (PD) states that Diablo Canyon will go to market when the rate freeze ends, a point in time which may not be known until many months after rate freeze has occurred. Richard stated that the reference in the PD to the potential use of an "interim" valuation should be deleted. Richard further stated that the PD should be modified to limit the carryover constraint to transition cost recovery, leaving non-transition cost recovery subject to existing ratemaking.

Summary: LATE FILED: On October 1, 1999, Thomas Long, Senior Telecommunications Attorney, met with Lester Wong, advisor to Cmmr. Bilas, in San Francisco. Long stated that the rate increase for Directory Assistance, if any, should be limited to the amount necessary to prevent below-cost pricing. Long further stated that offsetting revenue reductions should be required and based on the approved price ceiling since Pacific Bell (Pacific) has made clear that it intends to charge at least \$.50 for the service if permitted by the CPUC. Long stated that the proposed decision (PD) fails to address the impact of allowing such rates increases on the incentive and goals of the New Regulatory Framework (NRF) and that this is a broad policy issue that the Commission need to address. Long suggested that the decision include a statement that any rate increase that may be approved should not be considered precedential with respect to the broad policy issue, including the issue of revenue neutrality. Long also stated that if the PD is approved, Pacific and other NRF-regulated utilities can be expected to submit numerous requests for other service-specific rate increases as means of boosting their profits.

Summary: LATE FILED: On October 1, 1999, An all party meeting was held in the Commission’s office in San Francisco. In attendance were Cmmr. Duque, Michelle Cooke, advisor to Cmmr. Duque; Robert Finkelstein, staff attorney for The Utility Reform Network (TURN); Dan Richard, Jana Corey and Christopher Warner, for Pacific Gas and Electric Company (PG&E); Jim Price, Bob Kinosian, and Jason Zeller, for the Office of the Ratepayer Advocates; Mona Petrochko and Jeanne Bennett, for Alliance for Retail Markets; and Edward O’Neill, for the California Power Exchange. Finkelstein addressed the allocation of the “ongoing” CTC for certain categories of uneconomic costs that will continue to be collected after the rate freeze ends. Finkelstein noted that the general thrust of the Phase 1 proposed decision (PD) is to defer final resolution of the issue to Phase 2, and stated that TURN did not object to the outcome. However, in order to avoid the appearance of having predetermined the outcome in Phase 2, Finkelstein urged that the words “and afterward” be dropped from Finding of Fact 11. Finkelstein then addressed the utilities’ arguments for allowing the carrying over of costs incurred during the rate freeze so that they might be collected after the rate freeze has ended. Finally, TURN responded to PG&E’s position on whether the Incremental Cost Incentive Pricing Mechanism for Diablo Canyon was intended to be in place through 2001, or if it should terminate whenever the rate freeze terminates. Finkelstein also pointed out that PG&E’s reliance on the

Restructuring Rate Settlement is questionable since the document itself states that "Power from Diablo Canyon would be priced at market no later than January 1, 2002." Finkelstein concluded that to the extent the terms of AB 1890 constitute a "deal" between the utilities, the legislature, the Commission, and other interested parties, it was important to enforce the "deal" in a fair manner. Therefore, Finkelstein urged the Commission to support the PD as drafted on this issue.

Summary: On October 5, 1999, Ray Vlaitis, Utilities Engineer, for the Office of Ratepayer Advocates (ORA), met with Cmmr. Wood, in San Francisco. Written materials was provided and attached to the notice. Also present were Kevin Coughlan, advisor to Cmmr. Wood; Linda Gustafson, Program Supervisor, for ORA. ORA stated that it supported the proposed interim opinion on the petition of Pacific Gas and Electric Company (PG&E) for modification of Decision 99-06-080. ORA explained that the instant controversy concerning PG&E's Note 7 arises out of the investigation of PG&E's response to the December 1995 storms. ORA explained approximately 1500 wood utility poles failed during that storm. ORA also explained that currently various electric and telecommunications providers are vying for access to joint use wood utility poles and appear willing to sacrifice safety for access. ORA encouraged the Commission to move forward with a rulemaking to address the revision of wood pole minimum safety factors and their replacement or reinforcement. ORA stated that the Commission should consider adoption of wood pole standards and parameters contained in the National Electric Safety Code.
