Witherington discussed how Pacific Bell's unbundled network element loop prices must take into account the Universal Service Fund and Yellow Pages subsidies that Pacific Bell uses to support affordable residential local exchange service.

In its e-mail, Linsey stated that Finding of Fact 3 should be changed to reflect the draft decision's (DD) adoption of a 15 day notice to elect Power Exchange (PX)-based pricing. Linsey also stated that the text of the DD needs clarification concerning whether the true-up mechanism applies to line losses. Linsey stated that if the Commission wished to exclude line-loss adjustment from the scope of the true-up mechanism, it should apply a line loss factor of 1.0 to Qualifying Facilities that elect to receive payments based on the PX price.
