Summary: On October 18, 1999, Jan Smutny-Jones, Executive Director off IEP, met with cmmr. Bilas and Dorothy Duda, advisor to Cmmr. Duda; Cmmr. Wood, and Kim Malcolm, advisor to Cmmr. Hyatt in three separate meetings, in San Francisco. Also present was Doug Kerner, Counsel for IEP. Smutny-Jones urged to reject the Proposed Decision (PD) in the rehearing of Decision 97-04-082 in Application 96-03-031, indicating that the PD would have the Commission to reclassify as Interstate Transition Cost surcharge costs over \$88 million attributed to Southern California Gas Company stepdowns in capacity on both the El Paso and Transwestern Pipeline Systems. Smutny-Jones stated that if the PD, if accepted will (1) increase the fuel costs on electric generators which will result in an increase in the Power Exchange market clearing price such that consumer's electric costs may increase statewide; and (2) result in the electric customers of jurisdictional UDCs end up subsidizing the intrastate gas rate reductions of non-jurisdictional municipal customers. A letter stating these concerns was sent to all the Commissioners on October 19, 1999 and is attached to the notice.

During the meeting with Cmmr. Bilas, Condit discussed why the UNE loop price must contain offsets to recognize the subsidy support Pacific Bell draws from the Universal Service Fund (USF) and its Yellow pages services. A handout materials was provided during the meeting with Cmmr. Bilas and is attached to the notice. During the meeting with Tim Sullivan, Witherington discussed why the recently adopted SBC/Ameritech merger conditions will not effectively promote long-term residential local exchange competition in California. Witherington and Kargoll also discussed the FCC's recent USF order and its requirement.
