**Summary:** On December 13, 1999, Dr. Lee L. Selwyn of Economics and Technology, Inc. (ETI) a subcontractor in the contract between California Public Utilities Commission and Overland Consulting pursuant to the Office of Ratepayer's (ORA) Request for Proposal (RFP), wrote a letter (attached to the notice) to Cmmr. Bilas, Cmmr. Duque, Cmmr. Neeper, Cmmr. Hyatt, and Cmmr. Wood, in San Francisco. A copy of the letter was also hand-delivered to Administrative Law Judge Phil J. Weismehl. Summary: On December 14, 1999, David Morse, Project Manager and Hallie Yacknin, Assistant General Counsel), on behalf of the Office of Ratepayer's (ORA), met with Cmmr. Bilas, and Lester Wong, advisor to Cmmr. Bilas. And on the same day, met with Timothy Sullivan, advisor to Cmmr. Duque, in San Francisco. At the meeting with Sullivan, Lynne McGhee, Staff Attorney for ORA, participated. ORA stated that it supports the analysis and conclusion of ALJ Weismehl's Alternate Draft Decision, which would affirm that ORA should continue to perform the audit of Pacific Bell. ORA also stated that although it disagrees with the result of the Draft Decision (DD) of Cmmr. Duque that would transfer responsibility for the audit to the Telecommunications Division (TD), that determination is appropriately one of policy and subject to the Commission's discretion. ORA stated that, nonetheless, the DD grievously errs as a matter of fact and law in its discussion and findings that ORA did not comply with Commission direction regarding scope of the audit and consultant conflict of interest. ORA also stated that, if the audit is transferred to TD, Pacific Bell should be required to reimburse the Commission for ORA's consulting costs in conducting such a shadow audit. In addition, during the meeting Sullivan, ORA stated that the scope issues the DD raises (the sale of Bellcore and the merger between SBC and Ameritech) were not included in ORA's Request for Proposal or otherwise included in ORA's audit plan. ORA stated that DD claims that D96-05-036's rejection of ORA's audit plan for lack of specificity evidences ORA's failure to comply with Commission orders regarding scope of the audit.

Bilas, Cmmr. Duque, Cmmr. Neeper, Cmmr. Hyatt, and Cmmr. Wood, in San Francisco. A copy of the letter was also sent to Dorothy Duda, advisor to Cmmr. Bilas, Michelle Cooke, advisor to Cmmr. Duque, David Gamson, advisor to Cmmr. Neeper, William Julian and Linda Serizawa, advisors to Cmmr. Wood, and Kim Malcolm, advisor to Cmmr. Hyatt. In the letter, Southwest and Truckee expressed their unified support for the Alternate Decision, which approves the unanimously supported settlement between Southwest and Truckee, and their concern with the consequences that will flow if the Commission instead adopts the Draft Decision.
