San Diego Gas & Electric Company (San Diego) hereby transmits for filing the following changes in tariff schedules applicable to its Gas Department:

This filing is for the purpose of including as a part of San Diego's filed sample forms, a new form entitled Contract for Extension of Gas Facilities for Gas Cogeneration, Form 106-3359. The contract was designed to be used, when applicable, in negotiations with an applicant for natural gas service to be supplied under Sau Diego's Schedule GCG. San Diego proposes to require the applicant to execute the contract in situations where the facilities needed to supply the service requested will be in addition to, as enlargements of, as alternate to, or in substitution for, standard facilities which San Diego would normally install or use and which represent additional costs to San Diego over normally installed facilities.

The proposed contract provides for 1) San Diego to construct, own, operate and maintain the facilities, which are in addition to its standard facilities; 2) the applicant to pay to San Diego prior to installation the total installed cost of the facilities; and 3) the applicant to pay San Diego a sum which would be the estimated cost of removal of the facilities less the estimated salvage value of removable materials should the applicant cancel the contract or terminate use of the facilities at any time within five years immediately following the date the facilities are ready for service. The contract also provides for a refund should the applicant pay San Diego for future capacity and within a ten year period from the date of the contract the applicant elects to relinquish all rights to the unused capacity.

This filing will not increase any rate or charge, conflict with other schedules or rules, nor cause the withdrawal of service. Therefore, authority is requested under Section V.A. of General Order 96-A to make this filing effective on regular statutory (30 days) notice.
