In the Decision, the Commission stated: "we...retain a requirement of a minimum aggregation standard of fifteen customers per zip for residential, agricultural and commercial customers." The Commission also states: "we...follow a 15/15 Rule for public posting of data concerning commercial, industrial and agricultural data." (D.14-05-016, page 118; and Finding of Fact 17.) PG&E has redacted from the Report information from Table I-4 where there are fewer than 15 customers involved or where a single customer in the group accounts for more than 15% of the aggregated total. Please let us know if you have any questions or concerns about the redactions to comply with the Decision.
