WHEREAS: PACIFIC GAS AND ELECTRIC COMPANY, by Advice No. 94-E, filed December 19, 1950, having requested authority to make revisions in its tariff schedules effective on thirty days' notice as designated in

Schedules P-3, P-3-E, P-3-M, P-4, P-12-S, P-13, P-13-E, P-13-M, P-13-S, and P-22 set forth on Revised Cal. P.U.C. Sheets Nos. 1950-E, 1952-E, 1954-E, 1955-E, 1956-E 1958-E, 1960-E, 1962-E, 1964-E, and 1965-E, relating to the determination of motor load by test.

and having requested authority to transfer, to the appropriate unincorporated area rates, the customers in Orchard Tract No. 6 which tract previously was reported to have been annexed to the City of San Jose as the result of an election held February 24, 1949, which election has been invalidated by judgment of the District Court of Appeals, First District, Division 2 rendered on October 21, 1950, and

WHEREAS: Said revisions in tariff schedules and transfer of customers may result in increases in rates or charges requiring authorization by the Commission, and

It appearing that such increased rates or charges as may result from the above described revisions in schedules and transfer of customers are justified, therefore, good cause appearing,

IT IS HEREBY FOUND that such increases are justified, and

IT IS HEREBY ORDERED that authority be granted under Section 63(a) of the Public Utilities Act to make the above described sheets and transfers effective on January 18, 1951.

IT IS HEREBY FURTHER ORDERED that the company's Advice No. 94-E and the tariff sheets issued in accordance with the order herein contained shall be marked to show that they were issued under Resolution No. E-741 of the Public Utilities Commission of the State of California.
