SUBJECT: Order Authorizing Revisions in Tariff Schedules on Less Than Statutory Notice and Changes in Tariff Schedules which will Result in Increase in Rates or Charges.

WHEREAS: PACIFIC GAS AND ELECTRIC COMPANY, by Advice No. 108-E, filed May 24, 1952, having requested authority to make revisions in its tariff schedules as designated in Schedules C-4, C-5, D-4, D-5, DA-4, L-4, L-5, Preliminary Statement and Table of Contents, set forth on Cal. P.U.C. Sheets Nos. 2046-E to 2056-E, inclusive, relating to the establishment of Schedules C-4, D-4, DA-4, and L-4 within the corporate limits of Campbell and discontinuing the application of Schedules C-5, D-5, and L-5 within the Campbell Special Rate Area (15), and

WHEREAS said revisions will result in an increase in rates or charges for service to four customers presently within the Campbell Special Rate Area (15) but outside of the corporate limits of Campbell, and Pacific Gas and Electric Company has requested that said revision of its tariff schedules be made effective on less than thirty days' notice, namely, on one day's notice, and authorization therefor being required under the Public Utilities Code: and

It appearing that such increased rates or charges as will result from the above revisions in the schedules of rates applicable to service for the aforementioned four customers are justified; therefore, good cause appearing,

IT IS HEREBY FOUND AS A FACT that the increases in rates and charges resulting from the transfer of four customers from Schedule D-5 to Schedule D-6 because of the discontinuance of the Campbell Special Rate Area (15) are justified; and

IT IS HEREBY ORDERED that authority be granted under Sections 454 and 491 of the Public Utilities Code to make the above described tariff sheets effective on May 25, 1952.

IT IS HEREBY FURTHER ORDERED that the tariff sheets issued in accordance with the order herein contained shall be marked to show that such sheets were issued under Resolution No. E-784 of the Public Utilities Commission of the State of California.
