SUBJECT: Permission to Occupy Both Sides of Thoroughfare With Class "H" Lines.

WHEREAS: PACIFIC GAS AND ELECTRIC COMPANY having requested, by letter of March 23, 1953, permission to occupy both sides of certain thoroughfares with Class "H" lines in Santa Clara County, namely, Branham Lane approximately 4,000 feet and Los Gatos Almaden Road approximately 8,830 feet.

WHEREAS: In the absence of such permission this occupancy would constitute a violation of Rule 31.3 of General Order No. 95, and

WHEREAS: The Pacific Telephone and Telegraph Company and Los Gatos Telephone Company have by letter expressed approval with the proposed construction. The Pacific Telephone and Telegraph Company now occupies the opposite side of the street jointly with Pacific Gas and Electric Company for a distance of about 11,800 feet. Los Gatos Telephone Company presently contacts Pacific Gas and Electric Company poles a distance of approximately 1,030 feet on the opposite side of thoroughfare from the proposed extension.

IT IS HEREBY ORDERED that permission be granted Pacific Gas and Electric Company to occupy both sides of thoroughfares in Santa Clara County, beginning at the intersection of Branham Lane and Ross Road westerly along Branham Lane approximately 1,400 feet thence southerly along Branham Lane to the intersection of Los Gatos Almaden Road, a distance of approximately 2,600 feet, thence westerly along Los Gatos Almaden Road a distance of approximately 8,830 feet to the termination of the present 12-kv line. The proposed extension to be substantially in accordance with the sketch included with its letter of March 23, 1953. It is expected that the parties involved will cooperate with respect to the coordination of the protective equipment on both power and communication circuits to minimize the effect of accidental contact.

The Secretary is hereby directed to forward a copy of this resolution to the Pacific Gas and Electric Company, The Pacific Telephone and Telegraph Company and the Los Gatos Telephone Company.
