San Diego Gas & Electric Company Under Section X,
Paragraph A, of General Order No. 96.WHEREAS: SAN DIEGO GAS & ELECTRIC COMPANY having submitted for filing
and having requested authorization for Special Contract No. 59 with Escondido
Mutual Water Company dated April 30, 1954, andWHEREAS: Such contract provides for the purchase and sale of electric
energy between the two parties in accordance with the agreement for sale by
the Escondido Company and purchase by the San Diego Company of the Escondido
Company's electric distribution system and certain other properties in the
vicinity of Escondido, San Diego County, andWHEREAS: Said contract supersedes Special Contracts No. 12 dated
November 13, 1916 and August 27, 1940, and supplements thereto, and the
Commission being of the opinion that such authorization should be granted,
therefore,IT IS HEREBY ORDERED that San Diego Gas & Electric Company be authorized
under Section 532 of the Public Utilities Code to carry out the provisions of
said Special Contract No. 59 in accordance with the terms thereof, subject to
the following conditions:

1. That the Commission may hereafter, in the exercise of its juris-
diction, order modifications of or changes in the rates, terms,
and conditions applicable to public utility service now being
supplied by San Diego Gas & Electric Company under said contract,
and
2. The authorization contained herein shall not be construed as a
finding of the reasonableness of the rates, charges, terms, or
conditions under which San Diego Gas & Electric Company is
furnished with energy or other services by the Escondido Water
Company.

IT IS HEREBY FURTHER ORDERED that the contract hereinbefore authorized be
marked to show that it was authorized under Resolution No. E-852 of the
Public Utilities Commission of the State of California.The Secretary is directed to cause a certified copy of this resolution
to be mailed to the San Diego Gas & Electric Company and to the Escondido
Mutual Water Company. A certified copy of this resolution shall be filed
as a matter of record in Application No. 35233.I hereby certify that the foregoing Resolution was duly introduced, passed
and adopted at a regular session of the Public Utilities Commission of the State of
California, held on the 7th day of June, 1954, the following
