SUBJECT: Order Authorizing Revisions in Tariff Sheets which will Result in Increased Rates and Charges and Authorizing a Deviation from Filed Tariff Schedules

WHEREAS: PACIFIC GAS AND ELECTRIC COMPANY, by Advice No. 139-E, filed November 23, 1955, having requested authority to make revisions in its tariff sheet, Index of Cities, set forth on Cal. P.U.C. Sheet No. 2577-E, to become effective on December 23, 1955, and to transfer customers annexed to the City of Milpitas under Ordinance No. 42, from its tariffs applicable in an unincorporated area to its tariffs applicable within the City of Milpitas.

WHEREAS: Such transfer will result in an increase in charges to one customer through transfer from Schedule DM-1 to Schedule A-4, and

WNEREAS: Gustomer could continue to be served on Schedule DM-1 on a deviation basis, and

WHEREAS: It appears that such increased rates or charges are justified although not desirable; therefore, good cause appearing,

IT 13 HEREBY ORDERED that authority be granted under Sections 454 and 532 of the Public Utilities Gode to make Cal. P.U.C. Sheet No. 2577-5 effective December 23, 1955 and to render service, if the Pacific Gas and Electric Company so elects, on a deviation basis to the one customer, Francis K. De Vries, at the filed DM-1 rate.
