SUBJECT: BayPoint Light & Power Company, order authorizing electric tariff filing for purchased power adjustment to increase annual revenues of \$1,545 or 0.85%.

WHEREAS: BAY POINT LIGHT & POWER COMPANY by Advice Letter No. 73-E filed November 1, 1977, requests authority to increase its purchased power adjustment billing factor to become effective December 1, 1977.

Such filing complies with procedures and timing authorized by Decision No. 82549, dated March 12, 1974, and contained in Part 7 of the Preliminary Statement.

The proposed revenue increase and resulting purchased power adjustment factors are shown in the following table.

The proposed increase corresponds to an increase in Pacific Gas and Electric Company's resale rates authorized by the FPC and effective November 1, 1977.

The increase in average rate per kilowatt-hour since January 1, 1976 is 34.1%. No change is made in rates for lifeline usages.

The present and proposed rates in Schedule D-1, Domestic Service, and the effect of these rates on the winter average bill are shown on the following tables.


