SUBJECT: Order Authorizing Pacific Gas and Electric Company to Increase Its Monthly Charges for Special Facilities Used Solely for an Individual Customer's Benefit

PACIFIC GAS AND ELECTRIC COMPANY (PG&E), by Advice Letter No. 891-E (Supplemental), filed March 30, 1982, requests authorization to increase its monthly charges for special facilities, installed for a customer's sole benefit and which cost more than the estimated installed cost of standard facilities. The requested increase in monthly rates is from 1.0 to 1.55 percent of the amount advanced by customer and from 1.75 to 2.75 percent for PG&E-financed special facilities. PG&E also requests to eliminate prospectively, the customer's option to have PG&E provide capital for the special facilities; this type of financing will be at PG&E's option.

In addition, this filing will revise Rules Nos. 2, 15 and 15.1, Schedules Nos. A-21, A-22, A-23, A-18A, A-18B and PA-2X, and Form No. 79-245, Facilities Charge Agreement, to conform with the above changes. Further revisions, requested for Rule No. 2, in accordance with Decision No. 93887, Finding No. 39, establish a record of circuits that are unable to be operated within limits for Class A circuits under the Commission's CVR program.

The staff of the Energy Service and Safety Branch has reviewed PG&E's supporting work papers and the advice letter filing and finds that the requested special facility charges have been restated at current levels and are reasonable and further finds that the conforming revisions to rules and schedules affected are reasonable.

This filing will not conflict with other schedules or rules nor cause the withdrawal of service, and will not increase or decrease any rates or charges, except the special facility charges and options authorized herein.

IT IS ORDERED that authority is granted to PG&E to revise its monthly special facility charges and delete for the future applicant customer's option to have PG&E provide funds for such special facilities as described above under Section 454 (G) of the Public Utilities Code and that Cal. PUC Sheets Nos. 7727-E through 7732-E inclusive, 7670-E, 7672-E through 7676-E inclusive, and 7678-E through 7690-E inclusive, be marked to show that the sheets were issued under Resolution No. E-1947, of the Public Utilities Commission of the State of California to become effective July 7, 1982. The effective date of this Resolution is the date hereof.
