R E S O L U T I O N

PERMISSION TO DEVIATE FROM RULE 54.9 OF GENERAL ORDER
 NO. 95 WITH RESPECT TO EXTENDED RACK CONFIGURATION
 FOR CONDUCTORS OF NOT MORE THAN 750 VOLTS

The Bureau of Electricity, Department of Public Utilities of the City of Alameda (Alameda) by letter dated December 10, 1982, has requested authority to use extended rack construction on its overhead electric facilities similar to that which was authorized for Pacific Gas and Electric Company (PG&E) by Resolution No. E-1013, dated February 9, 1959.

Alameda representatives indicated by telephone on February 22, 1983 that Alameda also wished the additional deviation authority for extended rack construction granted to PG&E by Decision No. 82-03-030 dated March 2, 1982 in Application No. 61052. Alameda had been unaware that PG&E's original deviation had been amended.

The Pacific Telephone and Telegraph Company, by letter dated March 22, 1983 states that the proposed deviations to the provisions of Rule 54.9 are satisfactory to that company as a joint user.

The Local Union 1245, International Brotherhood of Electrical Workers, by letter dated May 17, 1983, states that it has no objection to the requested deviations.

The Energy Service and Safety Branch of the Utilities Division has reviewed Alameda's proposal and agrees it is consistent with the deviations granted to PG&E for extended rack construction by Resolution No. E-1013 and Decision No. 82-03-030.

THEREFORE:

We find it reasonable to grant the authority requested, and


