RESOLUTION

REVISION OF SOUTHERN CALIFORNIA EDISON COMPANY'S (SCE) RULES 15 AND 15.1 TO PROVIDE AN INCREASE IN COSTS OF OVERHEAD LINE AND UNDERGROUND EXTENSIONS

By Advice Letter No. 608-E filed February 14, 1983, SCE requests authorization to increase overhead line and underground extensions costs as set forth on Cal. P.U.C. Sheets 7214-E through 7217-E. The facts are as follows:

- 1. Pursuant to Paragraph E.2 (Periodic Review) of SCE's Rules Nos. 15 and 15.1, SCE has reviewed the cost of construction for overhead line and underground extensions.
- 2. SCE based its review on costs of completed projects in 1981 and escalated these costs to reflect 1982 and 1983 costs.
- 3. Results of the review as stated in Advice Letter No. 608-E and attachments reflect costs which have changed by more than 10 percent since the last revision in costs was made on August 4, 1981. Based on this information, SCE proposes the charge for overhead line extensions be revised from \$6.00 to \$6.90 per foot, and the charge for underground extensions be revised from \$4.75 to \$5.55 per foot.
- 4. SCE has furnished copies of the filing to utilities and interested parties.
- 5. The staff of the Utilities Division's Energy Service and Safety Branch has reviewed SCE's filing and supportive workpapers, is of the opinion that it conforms to the 10 percent requirement of the Periodic Review paragraph of SCE's Rules 15 and 15.1, and recommends approval.
- 6. We find that these revisions are just and reasonable and in conformance with applicable portions of SCE's Rules 15 and 15.1.

THEREFORE:

- 1. Authority is granted under Public Utilities Code Section 454 for SCE to place the above-mentioned tariff sheets into effect today.
- 2. The above-mentioned Advice Letter 608-E and tariff sheets shall be marked to show that they were authorized for filing by Commission Resolution E-1985. This resolution is effective today.
