R E S O L U T I O N

SUBJECT: Order approving a Mitigation Monitoring Program for the Devers-Valley-Serrano Project; Southern California Edison Company, A.59982, D.84-10-034

The Commission, by Ordering Paragraph 3 of D.84-10-034, dated October 3, 1984, has instructed the Executive Director to prepare and present a mitigation monitoring program consistent with the discussion in the Environmental Impact Report for the project.

The features of the staff recommended program include:

1. The estimated total budget for the program is \$40,000 with a duration of two years. The required staff will consist of one staff project officer and contract specialist assistance.
2. The cost of the mitigation monitoring program will be fully reimbursable from SCE to the CPUC.

PROGRAM ACTIONS:

1. The Project Officer (Environmental Liaison Officer) provides independent review and approval of environmental surveys and mitigation action identified in the Final Environmental Impact Report (FEIR).
2. The Project Officer verifies that each of the mitigation measures identified in the FEIR, including those measures for which the federal, state and local agencies have primary responsibility for implementation, is met. The Project Officer resolves issues which develop when experience gained during Project construction or work on other projects and studies indicates that alternative mitigation measures to those in the FEIR may be more appropriate.
3. The Project Officer field checks construction and adherence to mitigation measures.
4. The Project Officer prepares a report for the Evaluation & Compliance Division detailing compliance achieved, problems encountered and recommendations.


The Commission finds that the program as presented fulfills the requirements for a mitigation monitoring program for the Devers-Valley-Serrano Project. In this resolution we approve the detailed program for the Devers-Valley segment; at some future date we expect to review the details of the Valley-Serrano segment, which will also be subject to review by the United States Forest Service.

THEREFORE, IT IS ORDERED that:

1. The staff shall implement the program as described in the attached document and in accordance with Decision 84-10-034.
2. The cost of the mitigation monitoring program shall be reimbursable by SCE to the CPUC.
3. This resolution becomes effective NOV 21 1984.
