## RESOLUTION

ORDER AUTHORIZING SOUTHERN CALIFORNIA EDISON COMPANY (SCE) TO IMPLEMENT TWO NEW STANDARD AGREEMENTS FOR USE IN SCE'S COMMERCIAL/INDUSTRIAL OFF-PEAK COOLING PROGRAM

By Advice Letter No. 687-E, filed June 11, 1985, Southern California Edison Company (SCE) submitted for filing two standard agreements for use in SCE's Commercial/Industrial Off-Peak Cooling Program. The facts are as follows:

1. The Commercial/Industrial Off-Peak Cooling Program was authorized by this Commission in SCE's 1983 General Rate Case in Decision No. 82-12-055, dated December 13, 1982. This filing establishes two standard agreements for use in SCE's Program.

2. Form No. 16-237-1 --Commercial/Industrial Off-Peak Cooling Program Feasibility Study Agreement, provides an incentive to the customer for conducting a feasibility study as part of SCE's Commercial/Industrial Off-Peak Cooling Program.

3. Form No. 16-237-2 --Commercial/Industrial Off-Peak Cooling Program Installation Agreement, provides an incentive to the customer for participation in SCE's Commercial/Industrial Off-Peak Cooling Program which sets forth the terms and conditions of participation in the program.

4. Contracts which are substantially like Forms Nos. 16-237-1 and 16-237-2 have been in use since approximately April 1983, in establishing the 32 customers who are presently participating in SCE's Commercial/Industrial Off-Peak Cooling Program.

5. Decision No. 82-12-055 which authorized the program did not specify that filed contracts would be required by this Commission. However, SCE believes that filed contract forms are desirable and will minimize potential customer concerns and inquiries over SCE practices under the program.

6. These Agreements will not increase any rate or charge, cause the withdrawal of service nor conflict with any rule or schedule, and will not be a burden on ratepayers.

7. Public notification of this filing has been made by mailing copies of the advice letter to other utilities and to governmental agencies. The Commission Staff has received no protests in this matter. Resolution E-2052 Meeting of July 24, 1985

The staffs of the Load Management Section of the Energy Branch 8. of the Evaluation and Compliance Division have reviewed this filing and recommends its approval.

9. We find that Form No. 16-237-1 and Form No. 16-237-2 contained herein are just and reasonable.

THEREFORE:

1. Southern California Edison Company is authorized by Section 491 of the Public Utilities Code and Section X.A. of General Order 96-A to place these two standard agreements for use in Southern California Edison Company's Commercial/Industrial Off-Peak Cooling Program into effect today.

The above advice letter and two standard agreements with their 2. accompanying tariff sheets shall be marked to show that they were acceptable for filing by Commission Resolution No. E-2052. This resolution is effective today.
