#### RESOLUTION

ORDER AMENDING RESOLUTION E-2089 AUTHORIZING PACIFIC GAS AND ELECTRIC COMPANY TO WITHDRAW ELECTRIC TARIFF SCHEDULES AS-18 AND AS-23

# BACKGROUND

By Resolution E-2062, dated November 13, 1985, the Commission authorized Southern California Edison Company (SCE) to implement a new rate schedule for interruptible service, Schedule I-5 - General Service - Large Interruptible. On April 2, 1986 by Resolution No. E-2077, the Commission then authorized SCE to revise Schedule I-5 to be consistent with the requirements of Public Utilities Code Section 743 (Senate Billl 1148) and thereby withdraw its Schedules SP-1 - General Service-Steel Producers, and SP-2 and SP-3 - General Service-Steel Producers-Interruptible, 60 days after the date of the Resolution.

By Resolution E-2080 on April 16, 1986 the Commission authorized Pacific Gas and Electric Company (PG&E) to revise Schedule A-21 - Medium General Time-of-Use Service, and A-22 - Large General Time-of-Use Service, and to implement four new time-of-use schedules to be consistent with the requirements of Public Utilities Code Section 743. On May 7, 1986 by Resolution E-2089, the Commission authorized PG&E to withdraw its Schedules AS-18 - Interruptible Service to Steel Producers, and AS-23 - Firm Service to Steel Producers, 30 days after the date of the Resolution.

On May 22, 1986, the Public Staff Division (PSD) brought to the Commission's attention a discrepancy between the time elapsing between the Schedules SP-1, SP-2, and SP-3, and the date of Resolution E-2089 and the date for withdrawal of PG&E Schedules AS-18 and AS-23. In the opinion of the PSD there is no reason to distinguish between the Commission's action bringing SCE and PG&E into compliance with Public Utilities Code Section 743. However, we do note that Section 743 does require the Commission to ensure

utility compliance no later than July 1, 1986.

### THEREFORE:

- 1. This Resolution amends the action taken by this Commission in Resolution E-2089.
- 2. Pacific Gas and Electric Company is authorized to continue the existing Schedules AS-18 and AS-23 until June 30, 1986. These schedules shall then be withdrawn by this Resolution effective July 1, 1986.
