ORDER ESTABLISHING 1987 UNDERGROUND CONVERSION  
BUDGET FOR SAN DIEGO GAS & ELECTRIC COMPANY

San Diego Gas & Electric Company (SDG&E) in its compliance letter dated January 22, 1987, in accordance with Ordering Paragraph 6 of Decision No. 73078, Case No. 8209, requests approval of its underground conversion budget for 1987, in the amount of \$18,195,000.

SDG&E's approved budget for 1986 was \$16,693,894. This conformed to the Commission's policy of encouraging this program and took into consideration the level of activity negotiated between the utility and the cities and counties in its service area. The utility's 1987 budget for overhead to underground conversion is approximately 9% higher than 1986.

In compliance with Ordering Paragraph No. 1 of Decision No. 82-01-18, in Case 8209, SDG&E has allocated its conversion budget for 1987 in the same ratio that the number of overhead meters in such city or unincorporated area of any county bears to the SDG&E system's total overhead meters.

It is found that there is a continuing need for conversion of overhead electric and communication facilities to underground and that an appropriate level of such activity has been negotiated between SDG&E and cities for the year 1987.

IT IS ORDERED that:

SDG&E shall budget \$18,195,000 for its 1987 underground conversion program.
